Metallium Announces Senior Executive and Operational Appointments

Stuart Fraser - Chief Financial Officer

His expertise includes debt and capital restructuring, international tax, audit and compliance, and corporate finance. Stuart holds a Bachelor of Business (Accounting) from Edith Cowan University and is a Chartered Accountant. He is also a graduate of the Australian Institute of Company Directors and has completed executive finance programs at IMD (Lausanne) and the Wharton School, University of Pennsylvania.
