

**Appointment of Non-Executive Director, Mr. Jonas Samuelson**

He served as President & CEO of Electrolux Group from 2016–2025, having previously held senior leadership roles including Group CFO, COO, and CEO of Electrolux Major Appliances EMEA. Before Electrolux, he was CFO at Munters and spent over a decade at General Motors and Saab in a series of senior finance, commercial, and business development roles across Sweden and the United States. He holds board positions at Volvo Car AB (STO: VOLCAR-B) and Perrigo Company (NYSE: PRGO), as well as private companies Axel Johnson and Rosti Group AB.

Mr. Samuelson holds a Master of Science in International Business Administration and Economics from Gothenburg School of Economics, Sweden.

In announcing the new appointment, Ansell Chair Mr. Nigel Garrard said, *“We are delighted to welcome Jonas to the Ansell Board. Jonas brings extensive international leadership and finance experience to the Board, together with a strong record of overseeing complex global operations. His expertise in international manufacturing, operational transformation and financial governance will support the Board in guiding Ansell’s long-term strategy and performance. We look forward to the contribution Jonas will make to our Board and to the future direction of the company.”*
