The options have been issued under the INOVIQ Incentive Option Plan and are issued at an exercise price of 1.5 times the 7-day volume weighted average price (VWAP) up to the grant date. The options vest in 3 equal tranches on the following dates on the condition the recipient remains employed by the Company on the vesting date:

1. Tranche 1: one third of the options will vest after 1 year;
2. Tranche 2: one third of the options will vest after 2 years; and
3. Tranche 3: one third of the options will vest after 3 years.

On vesting, each option will become exercisable into one full paid ordinary share in the Company upon payment of the exercise price.
