Australian Dairy Nutritionals Limited (ASX:AHF) – Request for Trading Halt

In accordance with ASX Listing Rule 17.1, Australian Dairy Nutritionals Limited (ASX: AHF) (**Company**) requests an immediate trading halt be granted by the ASX with respect to the Company's securities quoted on the Australian Securities Exchange.

Pursuant to ASX Listing Rule 17.1, the Company advises that:

- (a) the reason for the request is pending an announcement in relation to a proposed capital raising;
- (b) it anticipates that the trading halt will remain in place until the earlier of the commencement of normal trading on Tuesday, 27 January 2026 or the release of an announcement by the Company in relation to the proposed capital raising;
- (c) the Company is not aware of any reason why the trading halt should not be granted;
- (d) the proposed capital raising is material to the Company; and
- (e) there is no other information necessary to inform the market about the trading halt.
