## 34<sup>th</sup> Copper Concentrate Shipment Dispatched

**Perth, Australia:** Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of the 34<sup>th</sup> shipment of copper concentrate from its Al Wash-hi – Majaza copper-gold mine in Oman. The Al Wash-hi – Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

### Key Highlights

- **34<sup>th</sup> shipment of 1352 WMT copper-concentrate shipped on 21<sup>st</sup> January, comprising 236.6 MT copper and 3.7 Kg gold**

The Al Wash-hi Majaza copper-concentrate plant has achieved a production of 1352 WMT of copper-gold concentrate with approximately 236.6 MT of contained copper and approximately 3.7 kg of gold in its latest shipping cycle. This comprises the 34<sup>th</sup> parcel of copper-concentrate exported from the plant, and departed Sohar Port on 21<sup>st</sup> January.
