

Energy Technologies Limited 2Q FY2026 Quarterly Activities Report and Appendix 4C

Key highlights:

- December 2025 quarter cash outflow improvement on December 2024 quarter of 35.45%; and
- Raised \$1,525,000 by way of debt funding for additional working capital.

Energy Technologies Limited (ASX: EGY or “the Company”), is pleased to release its Quarterly Activities Report and Appendix 4C Quarterly Cash Flow Report for the period ended 31st December 2025 (“2Q FY2026”).

As previously flagged, the company is continuing to reduce cash outflows and reducing the working capital committed resulting in cash receipts for the quarter were 38.55% lower than the last quarter while cash outflows were reduced by 35.45% over the Previous Corresponding Period (Dec 2024 quarter). The results are consistent with management expectations as the Board continues to review opportunities to appropriately and sustainably resource the Company’s operations and focus on lowering cash outflows.


At the conclusion of 2Q FY2026 the Company maintained unused financing facilities of c. A\$8.9m which included c. A\$1.525m net proceeds from the additional debt funding received in 2Q FY2026. Whereas the facility headroom is adequate to support the business, the Board are finalising a strategy and capital management process from the opportunities that have been presented. The board will update shareholders once this has been decided.

ASX Listing Rule 4.7C.3

In accordance with ASX Listing Rule 4.7C, payments made to related parties included in item 6.1 of the Appendix 4C incorporate director’s fees, salary and superannuation benefits. EGY paid a total of \$64,818 in Director’s Fees, Salaries and superannuation to the related parties in this current quarter.

EGY confirms that it conducted business as usual there were no substantive changes to its activities during 2Q FY2026. EGY’S primary activity is the manufacture and sale of specialist industrial cables and ancillary products through wholly owned subsidiary Bambach Wires and Cables Pty Ltd.
