

## Quarterly Activities Report to 31 December 2025

29 January 2026

EMC Gold (ASX:EM3; “EMC” or “the Company”) is pleased to provide the following quarterly activities report for the period ending 31 December 2025.

### Operational update

#### Salave PIER application withdrawal

In November 2025 the Company formally withdrew its application for the Salave Gold Project (“Salave” or “the Project”) to be declared a Project of Strategic Interest (PIER) under regional legislation in the Principality of Asturias (refer [ASX announcement](#) 3 November 2025).

By withdrawing this application, EMC Gold preserved its right to submit a new and strengthened application in the future. Any future submission will incorporate additional documentation and evidence to further demonstrate the Project’s strategic value to the local and regional community.

The Company also reported on local community survey outcomes, the results of which showed a majority of residents (63.5%) support the Project, provided that EMC Gold meets its environmental and social commitments. These survey results reflect growing stakeholder engagement and support for the Project’s development.

#### WA exploration and tenement holding

No exploration activity was conducted at the Company’s Ivan Well exploration licence (E69/3818) near Wiluna in the northern Goldfields.

### Corporate update

#### Successful placement completed to Spanish Investors

During the quarter, the Company successfully completed an equity placement to a group of highly regarded Spanish and Asturian high-net-worth investors (refer [ASX announcement](#) 24 November 2025).

EMC Gold received firm commitments for €2,639,478 to place 79,887,349 Shares (in the form as Chess Depositary Receipts (CDI’s)) at an agreed issue price of AUD\$0.059 per CDI (FX rate used AUD\$/€EUR of 0.56).

The net proceeds are directed towards advancing detailed engineering of the Salave Gold Project. The Company has continued to demonstrate strong financial discipline throughout the period to support ongoing technical and development work on Salave.

## Black Dragon Gold changes name to EMC Gold Corporation

Black Dragon Gold Corporation changed its Company name to EMC Gold Corporation during the quarter, advising it had been certified under the Business Corporations Act of British Columbia (refer [ASX announcement](#) 12 December 2025).

The new ASX ticker code EM3 took effect from commencement of trading on 12 December 2025. There has been no change to the Company's Australian Registered Body Number (ARBN).

## Cash position

At 31 December 2025, EMC Gold Corporation held CAD\$4,836,000.

## Related party costs

During the quarter, the company paid a total of CAD\$97,000 to related parties for Director fees and salaries.

EMC Gold (ASX:EM3) is an exploration company with a global portfolio of exploration assets. The Company's flagship project is Salave, one of the largest undeveloped gold projects in Europe. The Company retains one exploration permit in Western Australia, Ivan Well, presenting an opportunity to explore for surface and sub-surface gold in the future. ## About Salave Gold Project

The project has a Measured Mineral Resource of 1.03 million tonnes grading 5.59 g/t Au, containing 0.19 million ounces of gold; an Indicated Mineral Resource of 7.18 million tonnes grading 4.43 g/t Au, containing 1.02 million ounces of gold, plus Inferred Resources totalling 3.12 million tonnes grading 3.47 g/t Au, containing 0.35 million ounces of gold.

The information in this announcement that relates to the Mineral Resource estimate for the Salave project was first released by the Company in its news release titled 'New NI 43-101 Mineral Resource Estimate Increases Resources at Salave' dated 25 October 2018.

EMC Gold confirms that it is not aware of any new information or data that materially affects the information included in the original announcement and that all material assumptions and technical parameters underpinning the estimate in the previous announcement continue to apply and have not materially changed.

A full technical report summarising the Mineral Resource estimate completed by Bara Consulting is available on the Company's web site ([www.emcgold.com.au](http://www.emcgold.com.au)) and posted on SEDAR. In addition to the current Mineral Resource, historical exploration work suggests there is the potential for additional mineralisation within EMC Gold's landholdings.
