### **Q2 FY26 – Operations**

Net cash from operating activities was negative in the second quarter totalling \$115,000 and negative \$225,000 for the half year to 31 December 2025.

### **Cash on hand at 31 December 2025**

The Company had funds / interest bearing deposits on hand totalling \$7,952m.

### **Corporate activities**

There are no further changes to the update in the Chairman's Address tabled at the Annual General Meeting on 21 October 2025 and released to the market on that day.

### **Suspension of Securities**

As previously advised to the market, SIV Capital Limited securities were suspended from quotation on 18 December 2024. ASX had determined at that time that SIV's operations were not adequate to warrant continued quotation of its securities and therefore the Company was in breach of Listing Rule 12.1 and further noting that until ASX could be satisfied the Company was in compliance with the Listing Rules, in particular Listing Rules 12.1 and 12.3, would not reinstate SIV's securities to quotation.

In the meantime, the Company will continue to release periodic disclosure to ensure the market is fully informed under Listing Rule 3.1-3.1B.
