

FAR NORTHERN RESOURCES DECEMBER 2025 QUARTERLY REPORT

Highlights:

- **Drilling recommences at Bridge Creek**
- **Successful Annual General Meeting**

Summary of Activities:

Following on from the successful Phase 1 drilling programme at the Company's Bridge Creek tenement in the Northern Territory, drilling commenced on Phase 2 at Bridge Creek during the December 2025 Quarter.

The Phase 2 drilling programme is designed to extend the known resource to the north and south of the current Resource as well as to test the historical drilling at Bridge Creek (see the Company's announcement of 16 October 2025). The Phase 2 programme consists of 29 holes and assays are expected to be received in the first quarter of 2026.
