December 2025 Quarterly Activities Report

FAR Limited (**ASX: FAR**) (**Company** or **FAR**), provides its quarterly activities report for the quarter ended 31 December 2025.

Highlights

- Woodside Energy (**Woodside**) advised the ASX on 28 January 2026 in its 'Fourth Quarter Report' that the Sangomar field offshore Senegal achieved average daily production rate of 99 Mbbl/d (100% basis, 84 Mbbl/d Woodside share) at 99.2% reliability.
- FAR entered into an agreement with Woodside to settle a claim arising from the sale of FAR's interest in the RSSD Project in 2021. Under the settlement, FAR paid US\$6,029,899 to Woodside, with provisions allowing for recovery if Woodside is able to recover the past petroleum expenditure that is the subject of the claim from the Senegal Ministry of Energy, Petroleum and Mines prior to 31 December 2030.
- Cash at quarter end was US\$1.9 million (unaudited).

Woodside Energy Contingent Payment

As part of the consideration for the sale of its interest in the RSSD Project in Senegal to Woodside Energy, FAR received rights to a Contingent Payment with a maximum value of US\$55 million.

The Contingent Payment comprises 45% of entitlement barrels (being the share of oil relating to FAR's previously held 13.67% of the RSSD Project comprising the Sangomar Field exploitation area of interest), multiplied by the excess of the crude oil price per barrel and US\$58 per barrel (capped at US\$70 per barrel). The crude oil price for this purpose is the simple average of the mid-points of bid and offers for Dated Brent. The Contingent Payment terminates on the earliest of 31 December 2027, three years from the first oil being sold (excluding periods of zero production), or a total Contingent Payment of US\$55 million being reached, whichever occurs first.

Woodside Energy's Fourth Quarter Report for the period ended 31 December 2025 which was released to the ASX on 28 January 2026 noted the following in relation to Sangomar:

- Achieved average daily production rate of 99 Mbbl/d (100% basis, 84 Mbbl/d Woodside share) at 99.2% reliability.
- Production remained on plateau until late October 2025 as expected with the facility continuing to perform strongly as it transitions to post-plateau operating rates.

FAR received in May 2025 a provisional calendar year 2024 Contingent Payment of US\$11.5 million. The payment is subject to the outcome of the reconciliation of the underlying oil entitlement volumes with each joint venture participant and the Senegalese Ministry of Energy, Petroleum and Mines. Following the reconciliation process, Woodside or FAR must pay the other the difference between the final and provisional amounts.

Woodside Energy Claim Agreement

FAR announced on 22 December 2025 that it had entered into an agreement with Woodside for the settlement of a claim of US\$6,029,899 under the Sale and Purchase Agreement relating to the sale by the FAR group of its interest in the RSSD Project to Woodside in 2021. The agreement also provided that if at any time prior to 31 December 2030 Woodside is able to recover the petroleum expenditure that is the subject of the claim from the Senegal Ministry of Energy, Petroleum and Mines, then Woodside will refund to FAR the corresponding amount.

Cash Balance and Expenditure (unaudited)

FAR had US\$1.9 million of cash at the end of the quarter. During the December 2025 quarter expenditure totalled US\$0.1 million, comprising mainly corporate and administration costs.

Other movements of US\$5.9 million in the quarter represents the net movement of US\$6 million payment to Woodside and proceeds of US\$0.1 million from interests earned for the December 2025 quarter.
