

## QUARTERLY ACTIVITIES REPORT FOR PERIOD ENDED 31 DECEMBER 2025

### HIGHLIGHTS

#### Swanson Tantalum Project

- **Post Quarter:** Arcadia announced approval of a trading halt requested from ASX pending the release of announcements regarding an earn-in on the Swanson Tantalum mine and a proposed capital raising.
- The expected announcement regarding an earn-in follows after several interested parties have highlighted the project's expansion potential beyond the original DFS parameters through exploration of surrounding tenements at the TVC Project, which could potentially underpin an extended mine life and higher throughput rates.<sup>1</sup>

#### Karibib Copper Gold Project

- **Binding agreement executed<sup>2</sup>** with Kaoko Metals Ltd during the previous quarter to advance the Project through a four-stage earn-in.
- **Immediate value delivered** via non-refundable deposit and **A\$400,000** of pro-rata staged cash payments.
- Additional upside through **Net Smelter Royalty** and up to **2.25m Kaoko milestone shares**.
- The transaction is set to commence once Kaoko Metals Ltd is admitted for trading on the ASX.

#### TVC Projects

*Includes the TVC Ta-Li & Ni-PGE Projects*

- Assessment of a potential drilling program which considered historical data that returned results of **0.71% Ni, 0.28% Cu, 0.84 g/t Pd and 0.4 g/t Pt** over 16m<sup>3</sup>, combined with recent exploration data including sediment sampling and LAG orientation sampling.<sup>4</sup>
- The Projects **remains in good standing, and discussions** during the quarter with a number of third parties occurred, **reflecting sustained and increasing interest** in the TVC Projects.

## **Bitterwasser Lithium Project**

### *Lithium-In-Clays Project & Lithium Brines Project*

- Arcadia **planned to conduct low-cost test-work** over brines to confirm the existence of mineralisation, where two laboratories previously produced conflicting mineralisation results.<sup>5</sup>
- Arcadia **planned to utilise previously announced infill lithium drilling results**<sup>6</sup> for the potential reclassification of the Bitterwasser Clay Project's inferred Mineral Resource to an **indicated Mineral Resource**.
- **The Project remains in good standing.**

## **Corporate**

- During and following the end of the Quarter, Arcadia continues to:
  1. Assess opportunities to secure additional farm-ins or joint ventures across its highly prospective portfolio of Namibian assets.
  2. Evaluate further value-accretive acquisitions that could complement its highly prospective Namibian project portfolio, with a focus on gold & critical minerals.
  3. Manage its cash position and expenditures prudently, maintaining the Company's focus on minimising shareholder dilution as feasible.
- As part of Arcadia's new strategic direction, Philip le Roux stepped down from his role as Director and Chief Executive Officer, and Johan le Roux resigned from his position as Non-Executive Director.<sup>7</sup>

**Arcadia Minerals Limited (ASX:AM7, FRA:8OH) (Arcadia or the Company)** is pleased to provide its Activities Report and Appendix 5B Cash Flow Report for the quarter ending 31 December 2025 ("Quarter").

Arcadia holds a diversified portfolio of exploration-stage assets across Namibia, targeting critical, strategic, and precious metals.

During and following the end of the Quarter, the Company made significant progress across its Swanson Tantalum Project and Karibib Copper-Gold Project by attracting two strategic groups. The Company also assessed the potential to conduct a drilling program over its TVC Project and low-cost test work over its Bitterwasser Lithium Project.

Consistent with Arcadia's ongoing strategy to maximise shareholder exposure and minimise dilution, Arcadia continues to focus on securing further project-level joint ventures and other value-accretive proposals across all projects held within its portfolio.

## SUMMARY OF MINING EXPLORATION FOR THE QUARTER

### Swanson Tantalum Mine ("Swanson")

During the Quarter, Arcadia conducted minimal exploration work on the Project.

Following the end of the Quarter, Arcadia advised that approval of a trading halt has been requested pending the release of announcements regarding an earn-in on the Swanson Tantalum mine and a proposed capital raising.

### **Karibib Copper Gold Project ("Karibib")**

During the previous quarter, Arcadia announced that it had executed a binding Farm-in Agreement with Kaoko Metals Pty Ltd ("Kaoko" or "Kaoko Metals") over its 80% interest in Karibib Pegmatite Exploration (Pty) Limited ("KPE"), the entity which, via its shareholding in Goas Pegmatite Exploration (Proprietary) Limited ("GPE"), holds an 85% stake in the Karibib in Namibia.<sup>8</sup>

Under the Agreement, Kaoko may earn up to a 100% shareholding interest in KPE through a four-stage farm in. Arcadia will be entitled to the following consideration under the Agreement (pro-rata to Arcadia's 80% interest in KPE):

- 1) A cash payment of **A\$150,000** payable on the Settlement Date.
- 2) A cash payment of **A\$250,000** upon the date that is 1 year from the Settlement Date;
- 3) The grant of a Royalty over the KPE licence; and
- 4) Milestone fully paid ordinary shares in the capital of Kaoko ("Kaoko Shares"), upon satisfaction of the respective Farm-in Stages:
  - i. Stage 2 Farm-In: **500,000 Kaoko Shares**.
  - ii. Stage 3 Farm-In: **750,000 Kaoko Shares**.
  - iii. Stage 4 Farm-In: **1,000,000 Kaoko Shares**.

In addition, it was agreed that **\$35,000** non-refundable deposit to KPE is payable within 5 business days of the execution of the Agreement (which has subsequently received during the Quarter).

Kaoko is a privately held mineral exploration company headquartered in Perth, Western Australia. It is spearheaded by Gerard O'Donovan a **highly successful corporate professional** who most recently led **Sun Silver (ASX:SS1)** through its **successful IPO** in May of 2025 and subsequent rapid resource growth at its Maverick Springs Silver Gold Project in Nevada, USA.

### Prospectivity of Karibib

Karibib is located in the highly prospective Damara Belt of Namibia and benefits from its proximity to several significant regional deposits, including the **Navachab Gold Mine** (~35 km to the north), **Osino Resources' Twin Hills Deposit** (~50 km north, acquired by Yintai Gold for US\$272 million in February 2024), and the **Kokoseb Gold Project** (owned by WIA Gold, (ASX:WIA), with a current market capitalisation ~A\$680m). Arcadia continues to believe that Karibib holds significant latent value that has yet to be tapped into, which can be fully

harnessed through the application of modern exploration techniques as previously announced.<sup>9</sup>

### **TVC Project Area**

#### *TVC Ta-Li & TVC Ni-PGE Projects*

During the Quarter, Arcadia conducted minimal exploration work on the Project.

During the previous quarter, Arcadia announced that it was assessing a potential 1,000m drilling program over the broader TVC Project area (includes EPL5047 and EPL7295), following the strong exploration signals generated from stream-sediment sampling and the review of historic datasets.<sup>10</sup> As previously announced, the Company considers the broader TVC Project area to be prospective for a wide array of critical minerals.<sup>11</sup>

### **Bitterwasser Lithium Project (“Bitterwasser”)**

#### *Includes the Lithium-In-Clays Project & Lithium Brines Project*

During the Quarter, Arcadia conducted minimal exploration work on Bitterwasser.

During the Quarter, Arcadia announced<sup>12</sup> that it was planning to conduct low-cost test-work over brines to confirm the existence of mineralisation, where two laboratories previously produced conflicting mineralisation results.<sup>13</sup>

Arcadia planned to utilise previously announced infill lithium drilling results<sup>14</sup> for the potential reclassification of the Bitterwasser Clay Project’s inferred Mineral Resource to an indicated Mineral Resource.

As previously announced,<sup>15</sup> the Company has decided to shift its focus from Bitterwasser to the other projects within its portfolio, aligning with the current reduced sentiment in the lithium market. Arcadia continues to maintain Bitterwasser in good standing, anticipating a recovery in the lithium market’s long-term fundamentals.

During the Quarter, Arcadia continued to advance discussions with potential strategic equity partners for Bitterwasser, which remain ongoing.

### **CORPORATE AND FINANCE**

During the Quarter, a total of \$19k was spent on activities related to the exploration and development of the Company’s Projects. The Company has not incurred any expenditure for mining production activities during the Quarter.

### Bitterwasser Lithium Project (50% effective Interest)

The Bitterwasser Lithium Project is a highly prospective lithium asset and is comprised of Lithium-In-Clays and Lithium-In-Brine exploration opportunities. The project has already shown promising lithium concentrations in clay-rich zones and has an established JORC resource (refer to tables in appendix 1 below). Covering a vast area, the project's large and underexplored areas continue to present significant growth prospects.

### TVC Projects (80% effective interest)

The TVC Projects focus on the Kum-Kum Intrusive Complex and the Tantalite Valley Complex, both of which shares a geological formation with strong nickel, copper and platinum group element (PGE) mineralisation. Historical data, combined with recent exploration data, highlights the area's potential for large-scale discoveries of these critical and precious metals.

### Karibib Copper-Gold Project (68% effective interest)

The Karibib Copper-Gold Project is located in the Damara Belt, a region known for hosting major copper and gold deposits. Located within a rapidly growing gold district, the project benefits from excellent infrastructure and access to skilled labour. The project has significant potential for a major discovery through the application of modern exploration technology, such as that used by Osino Resources, recently acquired by Yintai Gold for US\$272m in February 2024.

### Swanson Tantalum Mine (80% effective interest)

The Swanson Tantalum Mine is focused on tantalum, a critical material in electronics and industrial applications. In addition to the existing JORC resource which confirms the presence of high-grade tantalum, the project also includes multiple follow up pegmatite targets which

are prospective for tantalum, lithium and niobium. Significantly, Swanson represents a sustainable and ethical source of tantalum that can be sourced outside of conflict zones, such as Democratic Republic of Congo. A bankable feasibility study has been completed for the Project, which demonstrated robust financial outcomes using relatively conservative inputs.

### Swanson Tantalum Project Mineral Resource

At Swanson a revised JORC Mineral Resource of 2.59Mt at an average grade of 486g/t Ta<sub>2</sub>O<sub>5</sub>, 73g/t Nb<sub>2</sub>O<sub>5</sub> and 0.15% Li<sub>2</sub>O was announced on the 6 May 2022, which was derived from 52 drillholes drilled over 10 pegmatites.
