In realizing sustainable performance, ANTAM consistently strives to provide benefits by delivering added value to the community and the environment.

HIGHLIGHTS

ANTAM recorded its highest nickel ore production and sales performance in more than a decade. In FY25, nickel ore production reached 16.11 million wet metric tons (wmt), and sales of 14.58 million wmt.

During the same period, ferronickel production reached 16,064 tons of nickel in ferronickel (TNi), with sales volume reaching 10,528 TNi.

Gold sales in FY25 recorded 37,406 kg (1,202,631 troy oz.), in line with domestic demand that remained solid. Meanwhile, gold production in FY25 reaching 743 kg (23,888 troy oz.).

ANTAM recorded the highest bauxite production and sales achievement in the Company's history. In FY25, bauxite production reaching 2.83 million wmt, with sales of 1.89 million wmt.

Chemical Grade Alumina performance in FY25 also showed the highest achievement in the Company's history, with realized production of 181,690 tons of alumina and sales reaching 180,221 tons of alumina.

PRODUCTION AND SALES

During 2025 (January–December 2025, FY25), ANTAM maintained operational resilience amid regulatory adjustments, the suboptimal growth of the domestic bauxite industry, and constraints in the supply of gold feedstock. Through stronger operational execution, cost efficiencies, and integrated supply chain management, ANTAM sustained business continuity and delivered positive performance in FY25.

In FY25, ANTAM recorded its highest nickel ore production and sales performance in more than a decade since the implementation of the mineral export ban. This achievement was driven by increasing demand for nickel ore in the domestic market.

In the bauxite segment, ANTAM also recorded the highest production and sales in the Company's history in FY25. This achievement was driven by optimized mining capacity and productivity, as well as increased absorption from the domestic market.

In line with the improvement in bauxite performance, ANTAM's alumina production in FY25 also reached its highest level in the Company's history, driven by higher utilization rates and enhanced operational stability at the alumina processing facilities.

As part of its commitment to Environmental, Social, and Governance (ESG) principles,

ANTAM consistently implements good mining practices and operational excellence across all operational activities. ANTAM also continues to strengthen its sustainability practices, including the increased use of renewable energy sources and close collaboration with surrounding communities in delivering social and environmental responsibility programs within its operating areas.

GOLD

In the fourth quarter of 2025 (October–December 2025, 4Q25), the Company's gold mine production reached 153 kg (4,919 troy oz). ANTAM recorded total gold production in FY25 of 743 kg (23,888 troy oz).

Gold sales volume in 4Q25 amounted to 3,331 kg (107,094 troy oz). Gold performance in 4Q25 drove gold sales in FY25 of 37,406 kg (1,202,631 troy oz).

Global economic and geopolitical uncertainty, financial market volatility, and inflationary pressures have driven demand for gold as an investment instrument with hedging and safe-haven characteristics. Amid exchange rate volatility and interest rate change, ANTAM's gold products have remained top of mind among the Indonesian consumers for gold investment.

These conditions kept ANTAM's gold sales performance solid and contributed meaningfully to the Company's overall performance.

NICKEL ORE

During FY25, ANTAM's nickel ore production reached 16.11 million wet metric tons (wmt), a 62% increase compared to nickel ore production in the first twelve months of 2024 (January - December 2024, FY24) of 9.94 million wmt. In 4Q25, nickel ore production reached 3.56 million wmt, an increase of 35% from the production achievement in the fourth quarter of 2024 (October-December 2024, 4Q24) of 2.63 million wmt.

From a marketing perspective, nickel ore sales in FY25 reached 14.58 million wmt, a 75% increase compared to FY24 of 8.35 million wmt. In 4Q25, nickel ore sales recorded 3.35 million wmt, an increase 27% compared to 4Q24 of 2.64 million wmt.

In line with increasing domestic demand, FY25 represented ANTAM's highest nickel ore production and sales in more than a decade since the mineral export ban was introduced.

Throughout FY25, ANTAM's nickel ore was allocated to support Indonesia's nickel class two industry and to supply internal feedstock for the Company's ferronickel operations in Kolaka.

FERRONICKEL

Throughout FY25, ANTAM's ferronickel performance was influenced by adjustments to regulations related to minimum product selling prices. In FY25, ANTAM achieved ferronickel production of 16,064 tons of nickel in ferronickel (TNi), with sales volume of 10,528 TNi.

In 4Q25, ANTAM's ferronickel production reached 2,755 TNi, meanwhile ANTAM ferronickel sales amounted to 2,346 TNi.

During FY25, all ferronickel sales were absorbed by export markets, with major destinations including South Korea, India, and China as major stainless steel manufacturing hubs.

BAUXITE

Inline with capacity and productivity as well as stronger domestic absorption, ANTAM recorded its highest bauxite production and sales in the Company History in FY25.

In 4Q25, bauxite production reached 514,374 wmt. Cumulatively, bauxite production in FY25 reached 2.83 million wmt, significant increase 112% compared to FY24 of 1.33 million wmt.

In terms of sales, bauxite sales volume in 4Q25 recorded 785,972 wmt, up 23% from 638,758 wmt in 4Q24. During FY25, bauxite sales reached 1.89 million wmt, an increase of 157% from 736,188 wmt in FY24.

ANTAM bauxite production was allocated as feedstock for the Company Chemical Grade Alumina (CGA) plant, operated by PT Indonesia Chemical Alumina (PT ICA), and for sales to domestic customers.

CHEMICAL GRADE ALUMINA

In line with ANTAM's efforts to optimize operations at the Company CGA plant in 4Q25, PT ICA produced 47,465 tons of alumina, up 13% from 41,942 tons of alumina in 4Q24. Cumulatively, alumina production in FY25 reached 181,690 tons of alumina, up 23% from 147,826 tons of alumina in FY24.

Operational optimization throughout FY25 also supported alumina production, and marking the highest annual production level on record for the Company in FY25.

In terms of sales, alumina sales in 4Q25 totaled 45,453 tons of alumina, up 3% from 44,112 tons of alumina in 4Q24. During FY25, alumina sales reached 180,221 tons of alumina, an increase of 2% from 177,178 tons of alumina in FY24.

SUSTAINABLE BUSINESS DEVELOPMENT THROUGH MINERAL DOWNSTREAMING

In accordance with the Fifth Asta Cita, ANTAM is committed to reinforcing integrated mineral downstreaming to create sustainable domestic value added. This commitment is reflected through a series of downstream projects currently being developed as part of the Company's long-term growth strategy.

In gold commodity, ANTAM is advancing a project to develop a precious metals manufacturing facility in the Java Integrated Industrial and Ports Estate (JIPE) in Gresik, East Java. The project entered the construction phase in the fourth quarter of 2025 and is intended to enhance the value of the Company's gold business by expanding Logam Mulia gold manufacturing capacity. This initiative is aligned with the Fifth Asta Cita through the implementation of downstreaming to enhance domestic value added. In addition, the initiative reflects the Company's efforts to address rising market demand and expand the development of the domestic gold market.

In nickel, ANTAM has achieved several key milestones under the cooperative project to develop Indonesia's EV Battery ecosystem, including completion of early works, progress on permitting, and financing preparations to support construction readiness in line with the target schedule. Following the groundbreaking for the integrated battery plant development in Karawang, West Java and East Halmahera, North

Maluku on June 29, 2025, the project has moved into the construction phase in East Halmahera. This milestone is marked by the commencement of EPC construction activities in the fourth quarter of 2025, as part of the development of the national battery ecosystem.

To strengthen bauxite downstreaming, ANTAM continues to support the integration of the national aluminum industry through the Smelter Grade Alumina Refinery (SGAR) Mempawah Project.

As part of the pathway toward commercial operations, ANTAM ensured bauxite supply availability to support consistent alumina production throughout the commissioning phase, while also conducting a trial alumina shipment to the Kuala Tanjung aluminum smelter as part of integrated supply chain validation.

By maintaining continuity of bauxite supply to the SGAR Project operated by PT Borneo Alumina Indonesia, a joint venture between ANTAM and INALUM, ANTAM reaffirms its role in supporting the development of a sustainable national aluminum industry ecosystem.

EXPLORATION ACTIVITIES

ANTAM's exploration activities focus on gold, nickel and bauxite commodities which are intended to sustain operations and development projects. ANTAM's total preliminary unaudited exploration expenses in FY25 amounted to Rp245.76 billion. As part of the effort to increase the portfolio of gold reserves and resources, ANTAM is currently focusing on searching for additional gold sources both in active Mining Business Permit locations and in other new prospect areas.

ANTAM through the Geomin Unit carries out integrated mineral exploration activities which include area survey activities, geological exploration, geophysical exploration, geodetic surveys, drilling, physical and chemical analysis testing, calculation of mineral reserves and resources supported by an integrated Geographic Information System (GIS). Exploration activities are carried out to ensure the adequacy of the Company's potential strategic mineral resources and reserves.

GOLD

In FY25, ANTAM conducted gold exploration activities in Pongkor, West Java. In Pongkor, ANTAM conducted in underground drilling, surface drilling, geological mapping and sampling.

NICKEL

ANTAM's nickel exploration FY25 is in North Konawe and Pomalaa, Southeast Sulawesi. In addition, exploration activities were also conducted on the Mining Business License (IUP)

of ANTAM's subsidiary, PT Sumberdaya Arindo (PT SDA), in Buli, North Maluku.

In the North Konawe area, activities carried out include single tube drilling, geological mapping, grid measurement, core sampling, resistivity geophysical, and laboratory analysis.

In the Pomalaa area, activities included single tube drilling, geological mapping, core sampling, and laboratory analysis.


Meanwhile, exploration activities in the Buli area by PT SDA include single tube drilling, geological mapping, grid measurement, and sampling.

BAUXITE

Bauxite exploration activities in FY25 were conducted in Tayan, Landak and Mempawah - Toho, West Kalimantan. In the Tayan area, the exploration activity was test pit, geological mapping, sampling, and chemical analysis.

In the Landak area, the activities carried out were land identification, geological mapping, test pit drilling, measurement and installation of benchmark (BM), and grid test pit measurement. Meanwhile, in Mempawah - Toho, conducted test pit, geological mapping, sampling, and chemical analysis.

ANTA HELD EXTRAORDINARY GENERAL MEETING OF SHAREHOLDERS FOR THE YEAR 2025

On December 15, 2025, ANTA announced that the Company held Extraordinary General

Meeting of Shareholders for the Year 2025 ("EGMS")

The First Agenda of EGMS, the shareholders approved the Amendment of the Company's Articles of Association. The Amendment relates to the adjustment to the provisions of Law Number 19 of 2003 concerning State-Owned Enterprise at last amended by Law Number 16 of 2025 regarding the Fourth Amendment to Law Number 19 of 2003 concerning State-Owned Enterprises ("SOE Law").

The Second Agenda of EGMS, the shareholders also resolved to approve the delegation of authority to the Company's Board of Commissioners to grant approval for the Company's Work Plan and Budget (RKAP) for 2026 and the Long-Term Plan (RJPP) for the 2026–2030 period, including any amendments thereto. This is in line with the provisions of Article 15G paragraphs (2) and (5) of the SOE Law. In addition, the shareholders ratified the changes in the composition of the Company's management.
