## UPDATE ON JIANGXI COPPER OFFER FOR SOLGOLD PLC

DGR Global Ltd (ASX: DGR) ("**DGR**" or "the **Company**") refers to its ASX announcement dated **2 February 2026** titled "**Clarification Statement in Quarterly Regarding SolGold plc**" ("**Prior Announcement**").

As disclosed in the Prior Announcement, DGR is a significant shareholder in London Stock Exchange-listed SolGold plc ("**SolGold**"), and Jiangxi Copper (Hong Kong) Investment Company Limited ("**JCC**") has made an offer to acquire SolGold at 28 pence per share via a scheme of arrangement to be voted on by SolGold shareholders on 23/2/26. (the "**JCC Offer**"). The Scheme is unanimously agreed to by the SolGold Board.

Following further consideration, the DGR Board advises that its present intention is to support the JCC Offer in connection with the SolGold general meeting scheduled to be held at 10:00am (UK time) on 23 February 2026, in the absence of a superior proposal being received.

The Board notes that this statement reflects its current intention only and DGR reserves the right to change its position in the best interests of shareholders, including in the event that a superior offer or proposal emerge, or should circumstances otherwise materially change.

In accordance with DGR's governance policies, Nicholas Mather abstained from Board deliberations and decisions relating to the JCC Offer.

DGR will continue to keep shareholders informed of any material developments in accordance with its continuous disclosure obligations.
