### Notice under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

Pursuant to section 708A(5)(e) of the Corporations Act 2001 (Cth) (**Act**), Manuka Resources Limited (**ASX: MKR; NZX: MKR**) (**Company**) gives notice to ASX of the issue of 5,666,666 fully paid ordinary Shares (**Shares**) following the exercise of 1,666,666 options exercisable at \$0.06 with an expiry date of 15 May 2026 and 4,000,000 options exercisable at \$0.10 with an expiry date of 7 August 2028.

The Shares were issued without disclosure to investors under Part 6D.2 of the Act.
