1. Offer

The Offer is an invitation to apply for fully paid ordinary shares in the Company (**Shares**) up to a maximum subscription of A\$30,000 at an issue price of A\$0.50 per Share (**New Shares**) (**Offer**).

The Offer is made on the same terms and conditions to all Eligible Shareholders (as defined in paragraph 2 below).

The Offer is non-renounceable.

2. Eligibility

You are eligible to apply for New Shares (**Eligible Shareholder**) if:

- (a) your registered address in the Company's register of members is in Australia or New Zealand (subject to the restrictions described in paragraph 16 below);
- (b) you were registered as a holder of Shares as at 5:00pm (AWST) on 30 January 2026; and

3. Issue Price
