

## Heritage Survey Completed at Crown Gold Project in WA

In preparation for aircore drilling, Auravelle has completed its second heritage survey at the Crown Gold Project, located southeast of Kalgoorlie in WA

Auravelle's 2025 aircore drilling successfully identified gold anomalism over at least 2km north-south (see ASX: 11/12/25)

This next round of aircore drilling will test historical drill intercepts and key structural targets, some of which are associated with Black Cat Syndicate's (ASX: BC8) nearby +500koz<sup>1</sup> Majestic gold mining centre, part of the Kal East 1.29Moz gold project<sup>2</sup>

Prior to the aircore drilling, Auravelle will undertake a focussed soil sampling program in the June quarter, in areas with no previous on-ground exploration

The soil sampling results, combined with the existing structural targets, will assist in refining the targets, ahead of the aircore drilling later in the year

**Auravelle Metals Limited** (ASX: **AUV**) ("Auravelle" or "the Company") is pleased to report the completion of a second heritage survey on the Crown Gold Project, with representatives for the Kakarra Aboriginal Corporation RNTBC. All key areas that Auravelle plans to test were assessed during the survey, covering key structures as well as historical drilling.

Ahead of the aircore drilling, Auravelle will undertake a focussed soil sampling program testing key targets in areas with no previous sampling or drilling. The targeted soils program is planned for the June quarter. The soil sampling will enhance AUV's understanding of the surface geochemical profile of the project, once combined with historical work. The results of the soils program will assist in prioritising targets ahead of the aircore drilling.

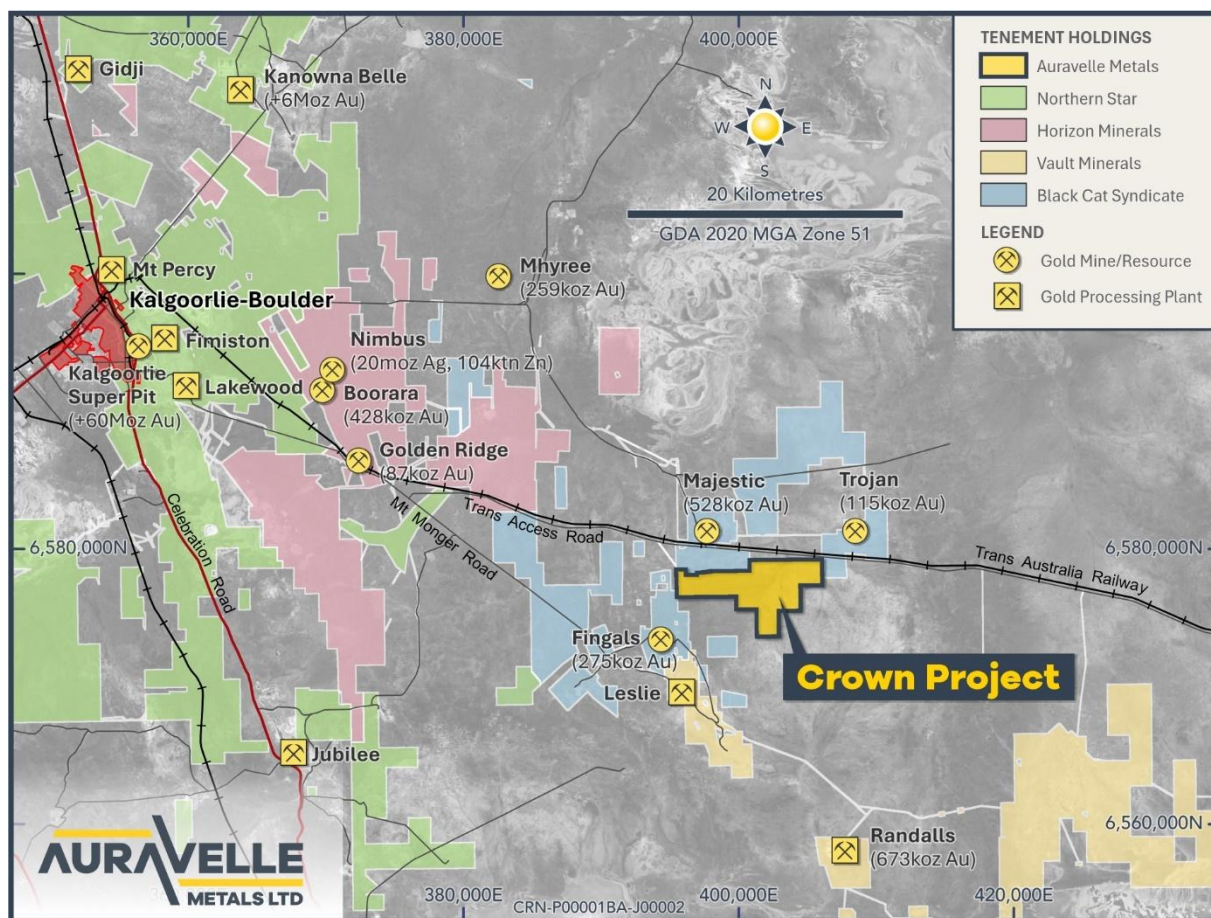
### **Auravelle Managing Director Andrew Muir commented:**

*"We would like to thank the Kakarra Aboriginal Corporation RNTBC for their assistance with the clearance assessment, and we look forward to drill testing a number of our targets later in the year."*

*"We were very pleased with the results from maiden drilling at Crown which confirmed and extended multiple areas of gold anomalism within the project. The anomalism is present over large areas, in multiple locations, and is at least 2km long in the central area. Combined with the maiden aircore results, we expect the pending soils program and subsequent aircore drilling later in the year, to assist with the refinement of gold targets to be tested with follow up deeper RC drilling."*

  - ⇒ **Maiden Auravelle exploration at Skye in South Australia**
