New Product Release – Shogun AV-19

Melbourne, Australia - Atomos Limited ('ASX:AMS', 'Atomos' or the 'Company'), provides an update on the recent release of its **Shogun AV-19** recorder monitor product with first sales expected to begin in late March 2026.

Shogun AV-19 is a larger format, 19-inch (compared to the flagship 5-inch Ninja range), rack-mounted monitor recorder product targeting the live production and broadcast markets. The Shogun AV-19 is the next evolution in Atomos historical Shogun Studio rack-mounted product line and is expected to be priced at USD \$1,999 (excluding local sales taxes and tariffs).

This is the 5th product release of new and upgraded products in the last 12 months and reinforces progress against Atomos' future product roadmap (refer [Link](#)). The progressive release of new products has resulted in a material improvement in sales and profitability, notably delivering H1'26 unaudited EBITDA of \$1.9m (versus H1'25 loss of \$5.6m).

In addition to core products, Atomos has also expanded its ecosystem portfolio of products, expanding into pro-audio (microphones and headphones), Wi-Fi-transmission and PTZ cameras.

Atomos Managing Director and CEO, Peter Barber, said, "Shogun AV-19 is built to be the go-to versatile, rack-mountable monitor-recorder-switcher for modern live production. We expect Shogun AV-19 to begin contributing meaningfully to revenue and earnings in Q4 of this financial year. In addition, and consistent with our product roadmap, further new product launches are expected over the course of this half."

- Comprehensive technical monitoring tools - EL Zone™ false color, focus peaking & waveform
- Transmit and receive NDI® HX3 over ethernet
- User-definable function buttons
