EZZ Appoints Aumake (ASX:AUK) as Exclusive Global Distributor for Co-Developed Products

Highlights

- EZZ has entered into a four-year global distribution agreement with Aumake Limited for a range of exclusive co-developed EZZ-branded products.
- The agreement includes minimum purchase commitments of A\$10 million over the initial term, with minimum annual purchases of A\$2.5 million.
- Aumake has been appointed as exclusive global distributor across all sales channels for the covered products.
- Aumake will manage sales, distribution and channel execution in accordance with EZZ's brand, quality and operational standards.
- The agreement supports EZZ's strategy to scale distribution through established international platforms and channels.

EZZ Life Science Holdings Limited (ASX: EZZ) (EZZ or the Company), a life science company dedicated to improving quality of life and human health, is pleased to announce it has entered into a global distribution agreement with Aumake Limited (ASX:AUK) (**Aumake**) for the distribution and sale of exclusive co-developed EZZ-branded products.

Under the agreement, Aumake has been appointed as exclusive global distributor across all channels for the products listed under the agreement. The initial term is four years, commencing February 2026, with automatic renewal periods subject to performance and termination provisions.

The agreement includes minimum aggregate purchase commitments of A\$10 million over the initial four-year term, with minimum annual purchase commitments of A\$2.5 million per contract year. Failure to meet the minimum annual purchase thresholds may result in the termination of exclusive distribution rights.

Aumake will be responsible for executing sales and distribution activities globally in accordance with EZZ's product specifications, brand guidelines and operational standards. EZZ retains ownership of all intellectual property and maintains oversight of product integrity, branding and compliance.

This agreement aligns with EZZ's strategy to expand global distribution through established platforms and channels, while maintaining disciplined capital allocation and brand control.

Chief Executive Officer, Mark Qin, commented:

"The appointment of Aumake as an exclusive global distributor represents an important step in expanding EZZ's international distribution capability. Aumake's established infrastructure and platform experience provide an opportunity to scale selected EZZ products across global channels, while maintaining our focus on brand integrity and product quality."

Summary Terms of the Aumake Distribution Agreement:

- **Distributor:** Aumake Limited
- **Territory:** Global
- **Exclusivity:** Exclusive global distributor across all channels for the covered products

- **Minimum purchase commitments:**
 - A\$10 million over the initial four-year term
 - Minimum A\$2.5 million per contract year
- **Brand & IP:** EZZ retains full ownership and control of intellectual property and branding
- **Termination:** Failure to meet either the aggregate minimum sales requirement or the annual minimum sales requirement shall result in the automatic termination of the worldwide exclusive rights granted.
