Monthly Activity Report for January 2026

Papyrus Australia Ltd (ASX:PPY) is pleased to report its activities pertaining to the month ended 31 January 2026 and the monthly Appendix 4C cash flow report released to the market on 27 February 2026.

Executive Chair Overview

Papyrus Australia made strong operational progress during January, advancing both the Rapid Prototyping & R&D Facility in Adelaide and the Australian Commercial Production Facility toward commercial readiness. These developments continue to validate our technology and support the Company's transition from development to early commercialisation.

At the R&D Facility, all major prototype systems were installed and commissioned during the month, enabling early production, product testing, and customer sample development. The first trays produced from the moulding line met quality expectations, and the establishment of a plantation-waste supply chain further strengthened operational readiness. January also saw Papyrus deepen its collaboration with the University's technology and industry hub through the University Internship Program, providing valuable analytical insight to the Company while offering students meaningful exposure to real-world technology development and iterative design.

The Australian Commercial Production Facility progressed through procurement and site establishment activities, with long-lead pulp-preparation equipment ordered and additional components prepared for shipment. Lease negotiations for the preferred manufacturing site advanced during January, positioning the project to move into installation and commissioning once finalised.

To support these critical-path activities, Papyrus received the final tranche of the \$500,000 in investor loans during the month. The Board expresses its sincere appreciation for the confidence and support shown by investors at this pivotal stage, enabling the Company to maintain momentum as it prepares for commercial production.

Papyrus enters February with strong operational traction and a clear pathway forward, well positioned to continue executing its commercialisation strategy and establishing itself as a leader in sustainable, high-performance fibre products.

Operational Activity

Rapid Prototyping & R&D Facility

The Adelaide Rapid Prototyping & R&D Facility progressed through several key commissioning stages, moving the site firmly into early production capability. This facility underpins Papyrus's product development, customer engagement, and certification programs.

Key Achievements

- **Prototype Primary Process commissioned and optimised**, enabling continuous fibre extraction trials and validating core mechanical performance.
- **Prototype Pulp Preparation system installed and commissioned**, establishing an integrated pulp-making for product testing and board-trial feedstock.
- **Moulding Line installed and undergoing commissioning**, with optimisation underway across heat, pressure, and cycle-time parameters.

- **Plantation waste supply chain established**, securing consistent feedstock for the facility and providing a pilot model for future commercial operations.
- **First trays produced from the moulding line**, with quality outcomes meeting expectations for strength, form, and surface finish.

Collaboration with University Partners

Papyrus has also strengthened its innovation ecosystem through a collaboration with Adelaide University's technology and industry hub, securing valuable support via the University Internship Program. This partnership provides Papyrus with fresh insight and analytical capability aligned with advanced manufacturing and sustainable materials. In turn, Papyrus is pleased to support the University and its students by offering meaningful industry experience in technology development, prototype optimisation, and the iterative design processes that underpin commercialisation of new technologies.

Commercial Production Facility – Australia

The Australian Commercial Production Facility advanced through its establishment phase, with procurement, site selection, and equipment readiness progressing in parallel. This facility will serve as Papyrus's first commercial-scale manufacturing hub, supporting high-end board production for industrial and mining applications.

Key Achievements

- **Long-lead equipment for the pulp preparation line ordered**, securing critical-path components for the production build.
- **Manufacturing site lease negotiations**, with the preferred location identified and commercial terms being finalised completion.
- **Pulp preparation equipment completed and ready for shipment**, enabling staged installation once the site is secured.

Financial Activity

1. Papyrus Australia received \$150,000 in loans from new and existing sophisticated investors completing the \$500,000 targeted across December and January for procurement of long lead equipment for the production facility.
2. During the month of January the following related party payment was made:
 - \$ 1,100 to David Attias Non-executive Director for reimbursement of travel costs

The expenditure reported for the month ending January 2026 Appendix 4C cash flow report for Papyrus relates primarily to:

- a. Prototyping equipment procurement costs
- b. Staff, legal, compliance and other overhead costs

There were no other payments to an associate or a related party.

The Company is in the process of applying for its next round of loans with Radium Capital. All prior loan applications have been approved and there is no current concern by the company that this round of loans will not get approval.</p>
