American Tungsten & Antimony Ltd (ASX: AT4) – Request for Trading Halt

In accordance with ASX Listing Rule 17.1, American Tungsten & Antimony Ltd (the Company) requests an immediate trading halt in the Company's securities from the commencement of trading on Friday, 6 March 2026.
