## Cover Note – Appendix 3Y Andrew Pridham and Christopher Wyke

We refer to the attached Appendix 3Y in respect of Andrew Pridham and Christopher Wyke.

On 9 March 2026 the trustees of Pre IPO Trusts (each a **Trust**) sold shares (**MA Financial Shares**) in MA Financial Group Limited (**MA Financial**) in order to meet contractual obligations of the relevant Trust<sup>1</sup>. As part of the sale the relevant Trust sold:

- 500,000 MA Financial Shares in respect of which Mr Pridham held an economic interest; and
- 120,000 MA Financial Shares in respect of which Mr Wyke held an economic interest.

The sales occurred within the approved MA Financial trading window.

Following the movements set out in the Appendix 3Y of Mr Pridham and Mr Wyke, entities related to:

- Mr Pridham continue to hold an economic interest in 15,472,763 MA Financial Shares, being 96.7% of his prior beneficial holding; and
- Mr Wyke continue to hold an economic interest in 7,050,096 MA Financial Shares being 96.7% of his prior beneficial interest.
