Webjet Limited ("WEB") – Collar Adjustment Event

On 23 May 2024, you entered into Transactions with UBS AG Australia Branch ("UBS") on the terms of the Agreement set out in the UBS Structured Option and Loan Facility Product Disclosure Statement dated 5 June 2014 (the "PDS").

The purpose of this letter is to inform you of a demerger and change of name announced by WEB, and the implications of this on your holding of WEB shares as Underlying Securities under the PDS.

Capitalised terms that are used in this letter and not defined herein have the meaning given to them in the PDS.

Background

On 22 May 2024, WEB announced its intention to undertake a demerger of its Webjet B2C business. The demerger would be implemented through the creation of a standalone company listed on the ASX, named Webjet Group Limited ("WJL") ("Demerger"). WEB would be renamed "WEB Travel Group Limited" post-Demerger. The Demerger and change of company name were approved by WEB shareholders on 17 September 2024. The Demerger was implemented on 30 September 2024 and the conditions for the conditional market in WJL were satisfied on 30 September 2024.

Under the Demerger, WEB shareholders received 1 new WJL share for each Underlying Security held on the record date of 24 September 2024. Below is the timetable provided by WEB:

Adjustments

UBS determined the Demerger to be an Adjustment Event and pursuant to clause 12.9 of 'Section 10 - Facility Terms' of the PDS, UBS has adjusted your Transactions as follows:

- The old Quantity of Underlying Securities held with UBS Nominees as Secured Property for the Collars increased to the new Quantity of Underlying Securities as outlined in the table below;
- The Strike Price for each Collar was reduced such that the new Quantity of Underlying Securities multiplied by the new Strike Price is the same as the old Quantity of Underlying Securities multiplied by the old Strike Price;
- The Cap Level for each Collar was reduced such that the new Quantity of Underlying Securities multiplied by the new Cap Level is the same as the old Quantity of Underlying Securities multiplied by the old Cap Level;
- The actual number of Underlying Securities held by UBS Nominees for your Transactions was increased by selling your new WJL shares at a market price of \$ [REDACTED] on 23 September 2024 and using the proceeds of the sale to purchase the required number of additional Underlying Securities (as identified in (a) above) for you at a market price of \$ [REDACTED] on the same date. These additional Underlying Securities form part of the Secured Property for your Transactions. All or part of the Underlying Securities purchased for you may have been sold by UBS or its affiliates as principal. There was a surplus of \$0.31 following application of the WJL sale proceeds to purchase the additional Underlying Securities, which will be paid to your nominated account on or around 3 October 2024; and
- References in your Confirmation and in any other notices sent to you by UBS to "Webjet Limited" are replaced by references to "WEB Travel Group Limited".
