Notice under section 708(5)(e) of the *Corporations Act 2001* (Cth)

This notice is given by Credit Clear Limited (ASX:CCR) (ACN 604 797 033) (the **Company**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (the **Act**).

On 17 March 2026, the Company issued 403,048 fully paid ordinary shares (**Shares**) for nil cash consideration at a deemed issued price of \$0.235703 to Related Parties (the **Related Parties**) in lieu of cash remuneration for Directors' fees, in accordance with shareholder approvals received at the annual general meetings held on 23 November 2023 (Resolutions 3b and 4b) and 22 November 2024 (Resolution 4).
