The Company announced an on-market share buy-back on 17 February 2026 as part of its total distribution amount for the half year ended 31 December 2025 of US4.0 cents per share comprising an unfranked interim cash dividend of US2.0 cents per share and the undertaking of an on-market share buy-back for ~US\$15.3 million (equivalent in total to US2.0 cents per share).
