





State of Our Industry and Business

1. Industry overview for 2024 - 2025
Game and Animation industries - went thru a tough time in 2025, with layoffs and uncertainties of mega M&A deals in North America.
2. We had maintained our project pipeline for 2024 largely because pent-up demand overflowing from the Covid-19 era.
3. Sales dropped for 2025 as we were reliant on North American market, especially for the animation industry.
4. We pivoted some resources to focus on European market (which is new to us) and yielding good results, especially for the Animation industry.
5. We hire localised talents in important global markets e.g. US, South Korea and Japan e.g. Mark Meyers and Richard Beresh that had joined our global team
6. Early 2026 is showing sign of recovery for the animation industry. We are currently extremely busy in the studios!



Proposed IPO Plan & Return of Value to ICI Shareholders

1. Proposed IPO entity Lemon Sky Nexus Inc
 - Structured to hold the business of LemonSky
 - 100% owned by iCandy Interactive Limited prior to fundraising or any potential corporate transactions
 - Delaware, US incorporation
 - Proposed ticker 'LSKY'
 - Currently assessing the appointment of advisors in the US (capital markets, legal, accounting)
2. Internal restructuring to occur once the advisers have been appointed.
3. Lemon Sky Nexus Inc intends to file a S-1 with US regulators seeking an IPO on NYSE American.
4. Aiming for IPO by end of 2026, targeting to raise US\$15m new capital at listing. iCandy Interactive Limited to retain significant stake.
5. It is intended that a portion of the shares in the proposed US-listed entity may be distributed to iCandy Interactive Limited shareholders directly, potentially via a return of capital and/or dividend-in-specie, subject to final structuring, regulatory approvals, and board determination.
