Bioxyne Signs Manufacturing Agreement with Global Cannabis Leader, Aurora Cannabis

Australian Bioxyne Limited (ASX: BXN) (“**Bioxyne**” or “**the Company**”), through its wholly owned subsidiary **Breathe Life Sciences (BLS)**, is pleased to announce that it has entered into a manufacturing agreement with **Aurora Cannabis Inc. (NASDAQ / TSX: ACB)** (“**Aurora**”), the Canadian-based leading global medical cannabis company.

Key Highlights

- Manufacturing agreement signed with Aurora, one of the world’s largest medical cannabis producers
- Initial agreement covers supply of GMP-certified medicinal cannabis oils into the Australian market, with initial deliveries already completed
- Agreement expanding to include GMP-manufactured cannabis vapes for supply into Australia, the United Kingdom and Germany
- This partnership underscores Bioxyne’s growing creditability as a global player in pharmaceutical-grade cannabis manufacturing and its ability to deliver high-quality, scalable solutions

Overview

Under the agreement, BLS will manufacture pharmaceutical-grade medicinal cannabis products for supply into key international markets. This collaboration highlights Bioxyne's evolution from a leading Australian manufacturer to a globally recognised brand, capable of partnering with top-tier industry leaders like Aurora, to meet the demands of highly-regulated, high-stakes environments.

The agreement marks a significant validation of Bioxyne's GMP-certified expertise in producing precision-dosed cannabis formats, positioning the Company as a trusted supplier on the world stage.

Chief Executive Officer Sam Watson commented:

“This partnership with Aurora represents a significant milestone for BLS as we expand our manufacturing capabilities. We are excited about the potential of our broader product portfolio across multiple international markets. This agreement validates our pharmaceutical manufacturing expertise and positions us well for growth.”

The companies have agreed to expand the scope of the manufacturing agreement and the onboarding process for the supply of additional product lines has commenced.

This expansion includes a large quantity of vapes, which will be produced and distributed into the Australian, UK and German markets.

Discussions are also progressing regarding the production of further products for supply into the for the Australian, UK and German markets, further expanding BLS's manufacturing capabilities and market presence.

Expansion: GMP-manufactured cannabis vapes, with additional lines to be confirmed

Term: initial 12-month rolling term with automatic renewal and terminable only on 6 months' notice
