Lumos receives largest FebriDx® order to-date

MELBOURNE, Australia (1 April 2026) – Lumos Diagnostics Holdings Ltd (ASX:LDX, “Lumos” or the “Company”) a leader in rapid, point-of-care diagnostic technologies, is pleased to announce that it has received its largest purchase order to-date from PHASE Scientific (“PHASE”).

Following the US FDA’s 510(k) PHASE clearance with CLIA waiver for FebriDx® on 27 March 2026, which unlocks a US\$1.0+ billion market opportunity and represents a 15x expansion of the addressable market for FebriDx®¹, Lumos’ US exclusive distributor, PHASE has lodged a purchase order valued at US\$1.3 million. This represents Lumos’ largest order for FebriDx to-date.

Commenting on the announcement, Doug Ward, CEO of Lumos Diagnostics said: *“Receiving our largest order to-date, so soon after the granting of CLIA waiver is a strong validation of the commercial opportunity for FebriDx® in the US market. We look forward to supporting PHASE as it scales its commercial rollout and drives adoption of FebriDx® across the much broader pool of urgent and primary care settings.”*
