Comments on the operations and the results of those operations are set out below:

For the quarter ended 31 March 2026, International Equities Corporation Ltd (IEQ) continued to deal with the effects of a sluggish economy. Higher operating cost, payroll, interest rates and inflation has hindered cost savings measures put in place. Revenue from tourism remains weak. Domestic and international travel are likely to be impacted by situation in the Middle East in months ahead.

As a result, IEQ has begun the process of returning the leases effectively ending operations at Seasons Heritage Melbourne. We expect confidence to remain bearish for another 6 months.

Apartments held have retained their value in the current economic climate. At this time the Company will hold off selling its stock of apartments in consideration of a lease rent.

This quarter saw revenue from the hotel division slow as we end leases. This segment resulted in an after-tax gain from continuing operations of \$0.235 million on revenue of \$0.090 million due to write back of provisions.

On Sales and Leasing activities the company will continue to actively list new properties for sale or lease. For the quarter revenues were \$0.277 million for a profit after tax stood at \$0.136 million from commissions on long term leases. The outlook for the year ahead remains stable.

For the quarter ended 31 March 2026, the Group generated revenues of \$0.589 million from leasing of property, hotel accommodation and related activities. This resulted in an after-tax gain of \$0.078 million.

This financial year Loss after tax per security was 0.13c (2025: Loss after Tax per security was 0.45c). Net tangible asset backing per security was 3.83c (2025: 4.88c)

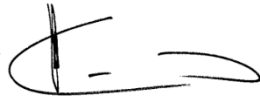
