Stonepeak-Plus Infra Debt Limited – Request for Trading Halt

In accordance with ASX Listing Rule 17.1, Stonepeak-Plus Infra Debt Limited (ABN 53 692 150 253) (**Issuer**) as issuer of the Stonepeak-Plus INFRA1 Notes (ASX: SPPHA) (**Notes**) requests that a trading halt be placed on the Notes with immediate effect.

The trading halt is requested pending an announcement by the Issuer in connection with a material capital raising to be undertaken by way of a wholesale placement (**Placement**).

The Issuer requests that the trading halt remain in place until the earlier of:

1. an announcement being made about the completion of the Placement; or
2. the commencement of trading on 22 April 2026.
