Drawdowns total \$6.5 million at 31 March 2026. An additional \$500,000 was drawn on 1<sup>st</sup> April 2026. Interest is payable on the outstanding balance at 15% per annum to the maturity date of 31 July 2027. Security charge in place over RNT Group assets and a \$1.5 million deposit in the Eldium Income Fund, which was increased to a total of \$2.5 million on 1<sup>st</sup> April 2026. This deposit is excluded from 8.3 below as it is restricted to use as funds for lending.</p>
