At the 2025 AGM, a resolution was put to the Meeting to approve the issue of LTI Performance Rights to Phil Hodgson for FY26. The Notice of Meeting stated that the LTI grant was intended to represent 30% of Mr Hodgson's full base salary, however, the number of Performance Rights that were approved to be issued at the Meeting was a number that represented 50% of his full base salary. Notwithstanding that the resolution approved an issue of more Performance Rights than was intended, the Board issued Mr Hodgson 486,445 LTI Performance Rights being that number of rights representing 30% of his full base salary.
