

USD\$500,000 RECEIVED FROM PNS

As U.S. Enterprise Contract Scales and Next Phase Discussions Commence

22 April 2026 – Singular Health Group Limited (ASX: SHG, “Singular Health” or “the Company”) is pleased to advise it has received USD\$500,000 from Provider Network Solutions (PNS) under the existing Binding Enterprise Agreement previously announced 19 June 2025, in respect of the deployment of Singular Health’s 3DICOM MD® licences in the U.S.

The payment from PNS represents balance of license fees and follows the deployment of an additional 500 3DICOM MD® licences, fulfilling contractual rollout obligations and further expanding the scale and reach across the PNS network.

PNS is a U.S.-based healthcare services organisation that manages care for approximately 4.2 million covered lives across its provider network, with a focus on delivering cost efficiencies and improved patient outcomes.

Singular Health’s Managing Director and CEO Denning Chong said:

“The receipt of this payment and the deployment of the next tranche of licences represents confirmation by PNS of the value of the 3DICOM MD® platform and are important milestones in scaling our commercial reach through PNS and its network and beyond.

We are encouraged by the ongoing performance of the platform, which is demonstrating its ability to deliver tangible cost savings and workflow efficiencies in a real-world healthcare environment.

We look forward to continuing to work closely with PNS as we progress discussions around renewal and expansion opportunities with PNS and its network.”

Dr Jose Pelayo, CEO of Provider Network Solutions said:

“We view a savings rate of 3%–5% of the US\$35 per member per month duplicate imaging costs as material savings, and we are currently exceeding all our expectations. This validates our belief in the strong future for the 3DICOM™ platform and its delivery of material reductions in duplicate imaging costs and enhanced efficiencies and interoperability across our network.

Based on the results we are seeing, the 3DICOM™ platform is well positioned to attract broader interest from more U.S. healthcare plans as outcomes from our usage are utilized. PNS remains committed in its strong belief in the future financial and commercial scaleability of the 3DICOM MD® platform.”

PNS Enterprise Agreement – ongoing success

The commercial implementation of the 3DICOM MD® platform within PNS and its network continues to progress positively, with increasing deployment and utilisation of Singular Health's 3D medical imaging platform within clinical workflows.

Continued observations indicate the platform is delivering meaningful cost efficiencies, particularly through reducing duplicate imaging and improving access to patient data across providers.

Given the ongoing success, Singular Health and PNS have commenced discussions regarding the renewal and expansion of the agreement beyond this initial term.
