Freedom Care Group Holdings Limited (**Freedom** or **the Company**) (ASX: **FCG**), is pleased to release its Appendix 4C Cashflow Report for the quarter ended 30 September 2025.

Key Highlights

- The Administrator, KPT Restructuring Pty Ltd (KPT), continued to experience challenges in collecting outstanding receivables from the NDIA during the quarter.
- Cash balance of \$0.4 million at 30 September 2025 (versus \$0.5 million at 30 June 2025).

Outlook

KPT continues to engage with the NDIA regarding the recovery of outstanding receivables; however, the NDIA has not been providing regular payments. KPT remains actively engaged with the NDIA and has continued to raised concerns regarding delays in responding to queries and the timing of payment of amounts outstanding.

The Company continues to explore all viable pathways to facilitate a relisting.

Financial and Corporate

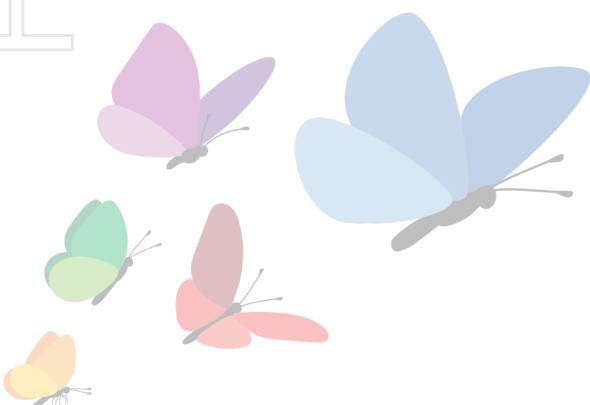
There were no payments to the Directors of the Company during the September 2025 quarter (see section 6 of the Appendix 4C).
