## MARCH QUARTER HIGHLIGHTS

- License renewals remain “Pending”
- Maiden Mineral Resource Estimate (MRE) pending
- Conversion of loan notes progressing
- As at 31 March 2026, Cash Balance of \$0.122m with the Company in discussions for additional funding

First Lithium Limited (“FL1”, or “the Company”) is pleased to provide an update on its activities for the March 2026 quarter.

### First Lithium Managing Director, Venkatesh Padala said:

“The renewal of the outstanding licences in Mali are expected to be finalised in the upcoming ministry meetings. Our project consultants expect the maiden MRE on the Project to be finalised once the project licences have been processed. Our combined teams remain in contact with the Mali Government and are all working to finalise the renewals”.

### PERMIT RENEWAL APPLICATIONS PENDING

The Government of the Republic of Mali had indicated licence renewals would be processed at their Q1 2026 Ministry meeting, it is now anticipated this will be in the Q2 2026 meetings. The government have previously acknowledged the Company has submitted all required information to obtain the outstanding renewals.

### MAIDEN MINERAL RESOURCE ESTIMATE (MRE)

Once licence renewals have been issued, the reporting consultants and the competent person have revised the expected timing for the maiden MRE, and believe it should be completed and issued to the Company in the June 2026 Quarter.

## MALI OVERVIEW

The partial lifting of the suspension of mining permits by the Government of the Republic of Mali occurred in March 2025<sup>1</sup>. Processing of renewals is underway and the Government is working through the backlog caused by the suspensions that had been in place since September 2022. Indications suggest Mali is set to secure the position of Africa's second-biggest lithium producer in 2025, with output anticipated to represent 14% of the regional total according to Benchmark's lithium forecast<sup>2</sup>.

## FUNDING FACILITY

The Company previously confirmed<sup>3</sup> it has secured an extended funding facility of \$800,000 which was received in two tranches, the first of \$400,000 in October 2025 and the second of \$400,000 by January 2026.

The Company is in the process of converting tranche one notes of \$1.2m to equity which will be outlined to the market via a Notice of Meeting currently being prepared, and will be subject to shareholder approval.

The Company is in discussions for additional funding, with the pending licence renewals and release of the Company's maiden MRE expected in the June 2026 quarter. Resolution of the funding solution will be announced separately once finalised.

## CORPORATE

First Lithium had a cash balance of \$0.122m at 31 March 2026. Exploration and evaluation expenditure incurred for the year to date was \$245k.
