Ainsworth Game Technology Limited (ASX: AGI) (**Ainsworth**) refers to the unsolicited proportional off-market takeover offer by Kjerulf David Hastings Ainsworth (**KDHA**) for 5.5% of each shareholder's ordinary shares in Ainsworth that KDHA does not own (**KDHA Proportional Offer**).

The KDHA Proportional Offer closed at 7:00 pm (Sydney time) on 27 April 2026. As at the close of the KDHA Proportional Offer, KDHA's voting power in Ainsworth was 8.24%.
