## NEW INFRASTRUCTURE IN PLACE

### RC & Diamond Rig Active on Site

#### Exploration camp fully operational

- Includes a kitchen equipped for >60 people
  - > capacity to support a scale-up of operations
- 65kl of diesel storage, filled prior start of drilling
- Core yard facility in place to speed up processing
- Fully functioning office and high-speed communications

#### Accelerated Drilling Program underway

- 10,000m of RC, 5,000m of DD and 15,000m of AC drilling
- RC rig drilling - Arrakis, Salusa, Flushing Meadows
- Diamond rig completed EIS drilling at Nayla April 2026
- Diamond drilling has commenced at Flushing Meadows below the shallow 268koz MRE

# GROWING THE ARRAKIS DISCOVERY

## Unlocking High-value Mineralisation

### Hosted within a previously unrecognised large-scale structure

- Large-scale Caladan fold structure, 3km wide >8km long, identified in 2024 from ground gravity survey

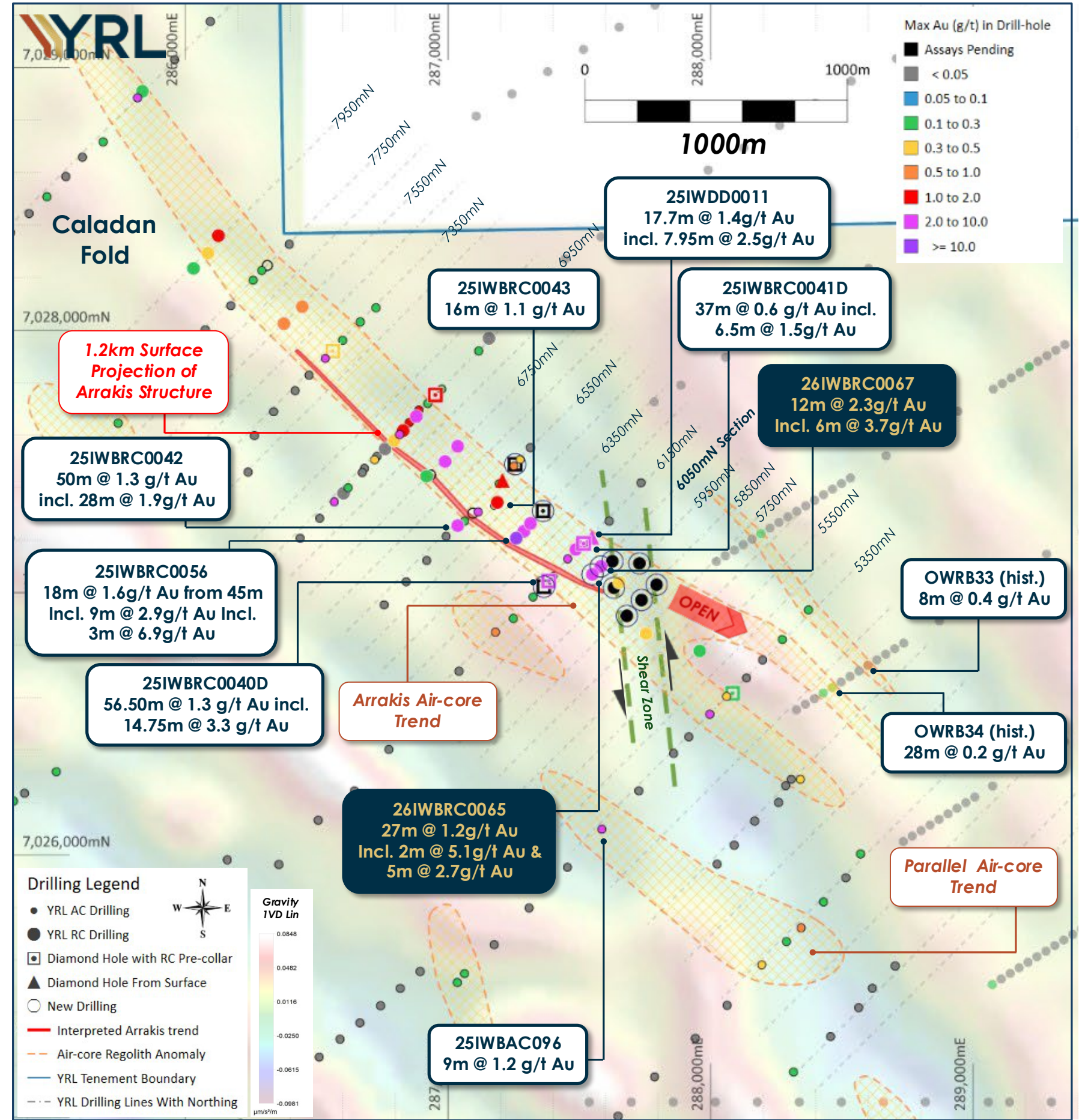
### Air-core drilling defined Arrakis

- Extensive >2.2km regolith anomaly defined in mid-2025

### First Results from 2026 RC drilling Extend Mineralisation Southeast

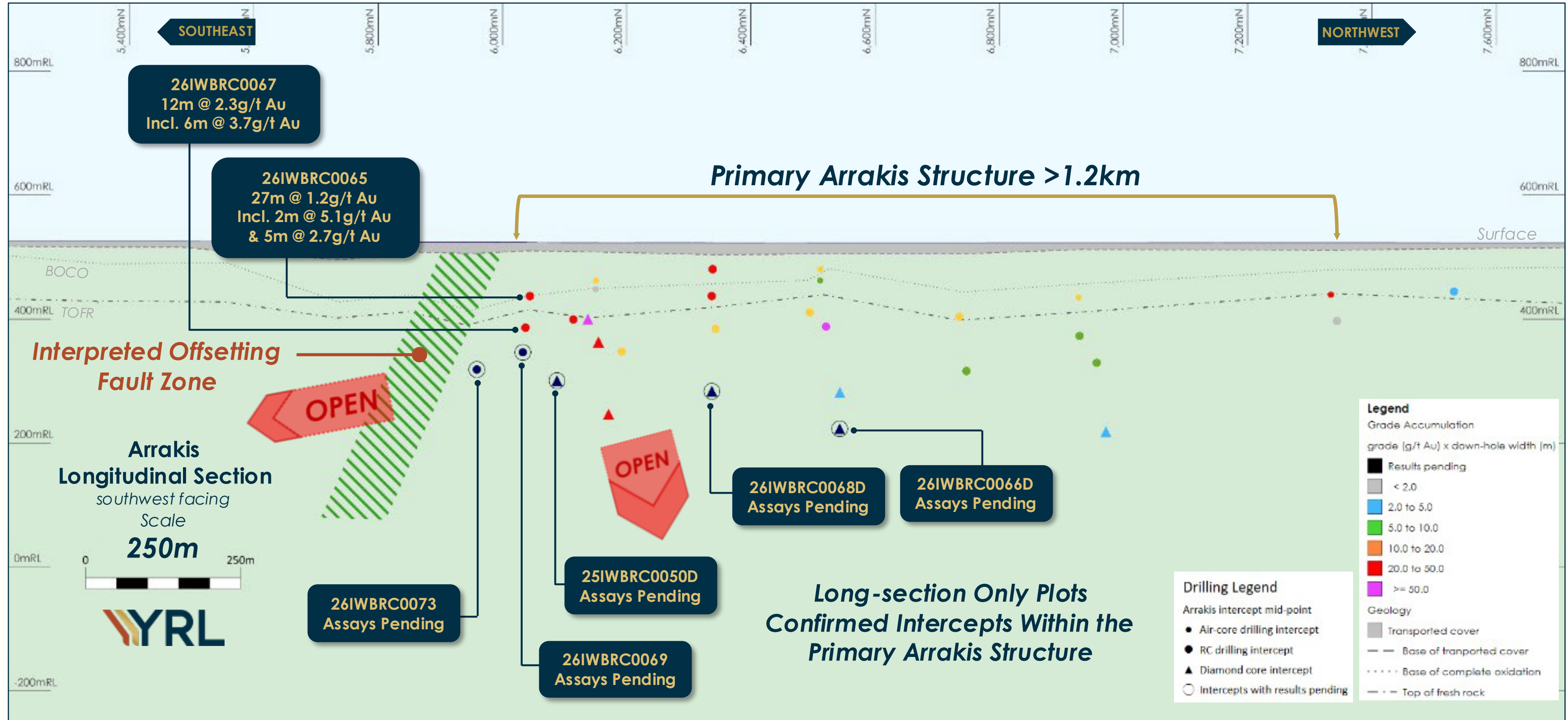
- 27m @ 1.2g/t Au from 87m (ETW\*<sup>1</sup> 20m), including
  - > 2m @ 5.1g/t Au from 89m, and
  - > 5m @ 2.7g/t Au from 100m
- 12m @ 2.3g/t Au from 152m (ETW\*<sup>1</sup> 10m), including
  - > 6m @ 3.7g/t Au from 152m

# ARRAKIS GOLD DISCOVERY

## Defining the Mineralised System

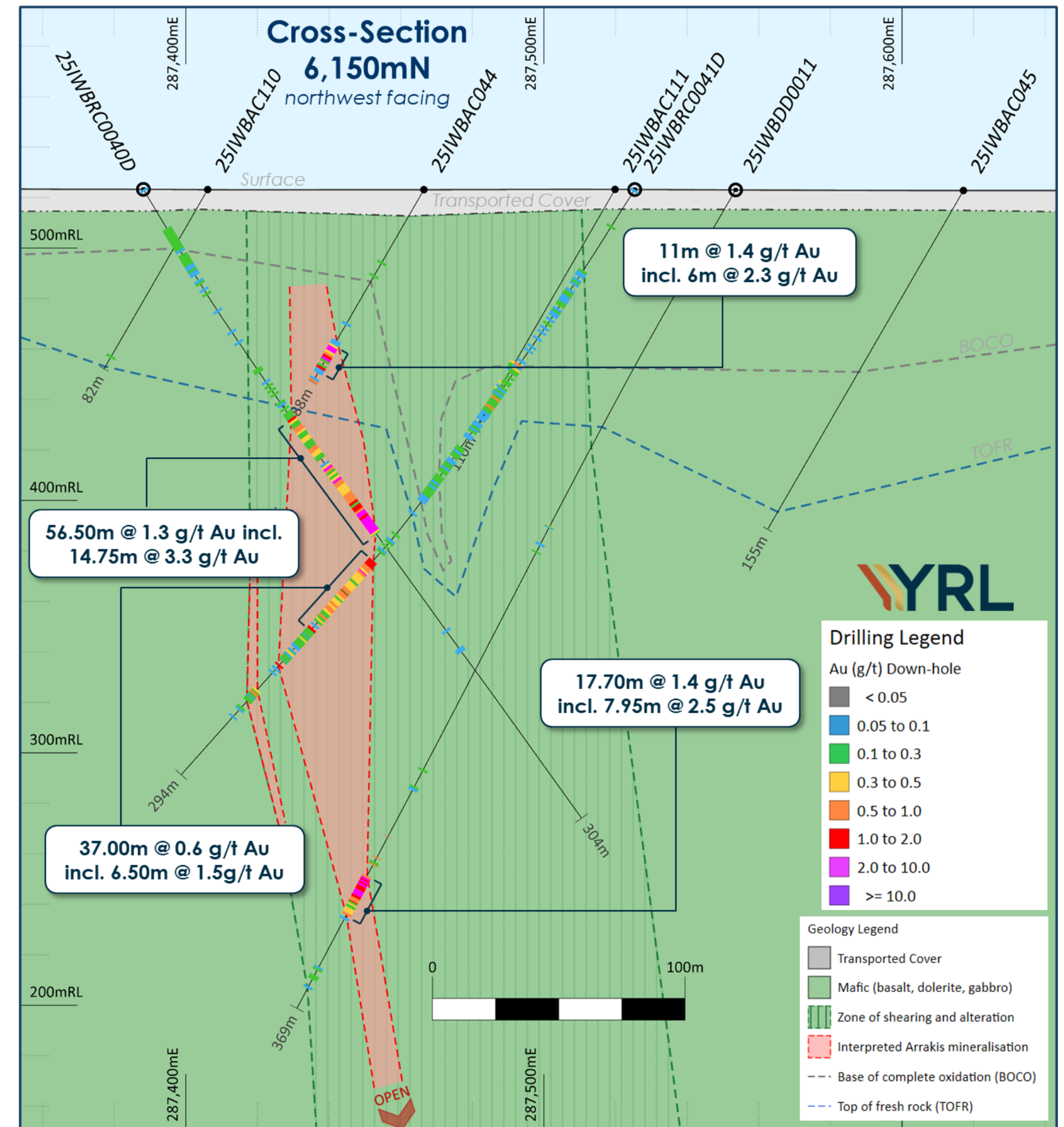
### RC drilling defined a 1.2km primary mineralised structure

- Both broad style lower-grade mineralisation and narrower high-grade mineralisation
- Potentially **open to the southeast**
- Evidence of **mineralisation continuity** both along strike and down dip with targeted close-spaced drilling

### Objectives for 2026

- Step out drilling to the southeast – **How big is the system?**
- Targeted closer-spaced RC and diamond drilling to **define high-grade trends** and geological controls
- Infill ground gravity to refine targeting models
- Targeted deeper diamond drilling to evaluate continuity at depth

# TARGETING SCALE AT NEG

## Significant Discovery Potential

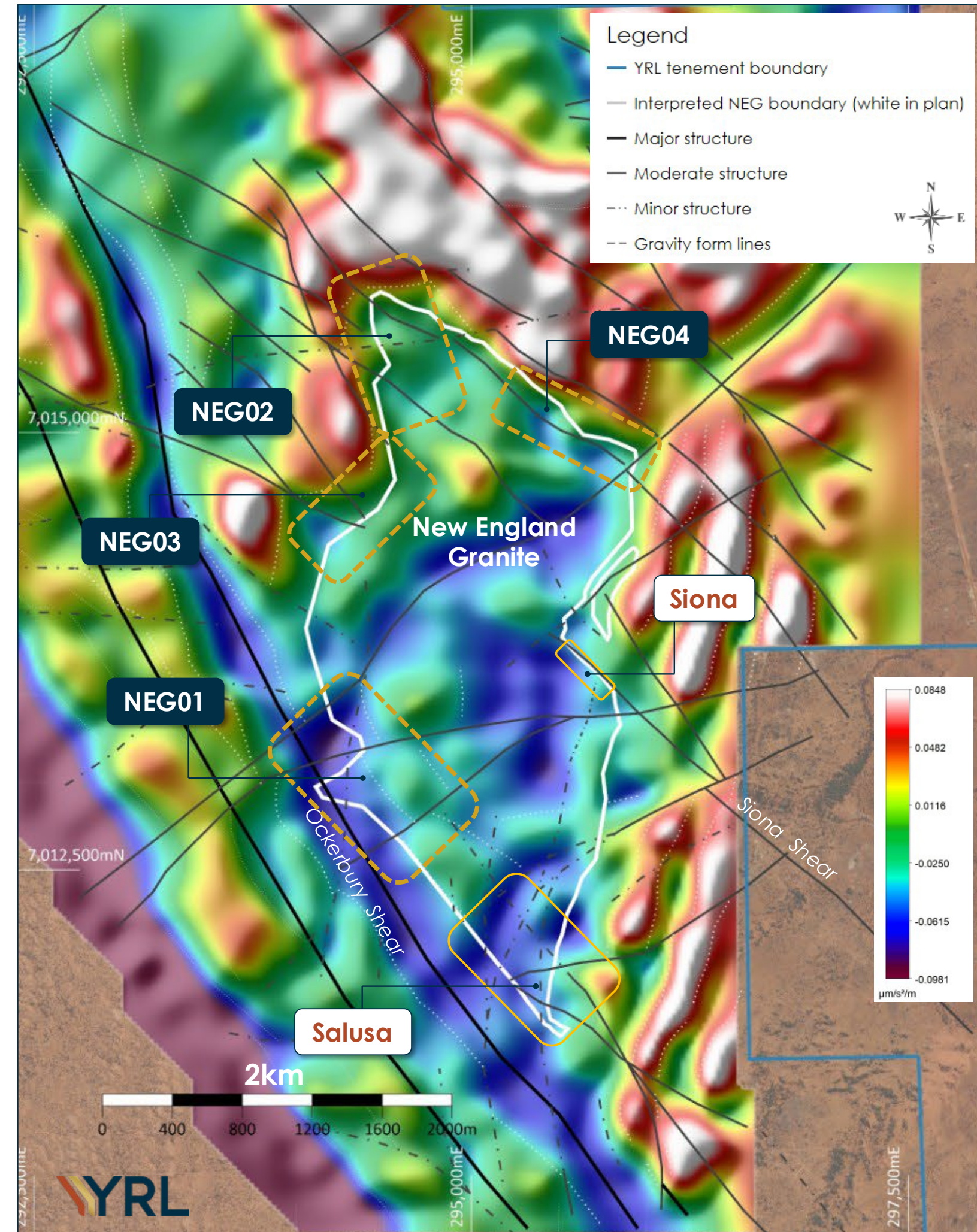
### Large-scale host interacting with multiple structures

- The Siona gold discovery confirmed the **large intrusive complex** as a host for mineralised systems
- Siona Shear zone is one of **several significant structures** interacting with the New England Granite

### Drilling to focus on advancing new discoveries

- 2025 AC program delivered a **new high-grade Salusa** target  
**6m @ 6.3g/t Au** from 36m incl. **2m @ 18.1g/t Au**
- 2026 AC to focus on the western margin once heritage clearance is received **~5.5km of western margin untested**
- Small program to assess high-grade oxide mineralisation at Siona  
**17m @ 4.9g/t Au** from 85m in 24IWBRC0050  
**14m @ 1.8g/t Au** from 63m in 25IWBRC0044

# FLUSHING MEADOWS

268koz Gold Mineral Resource

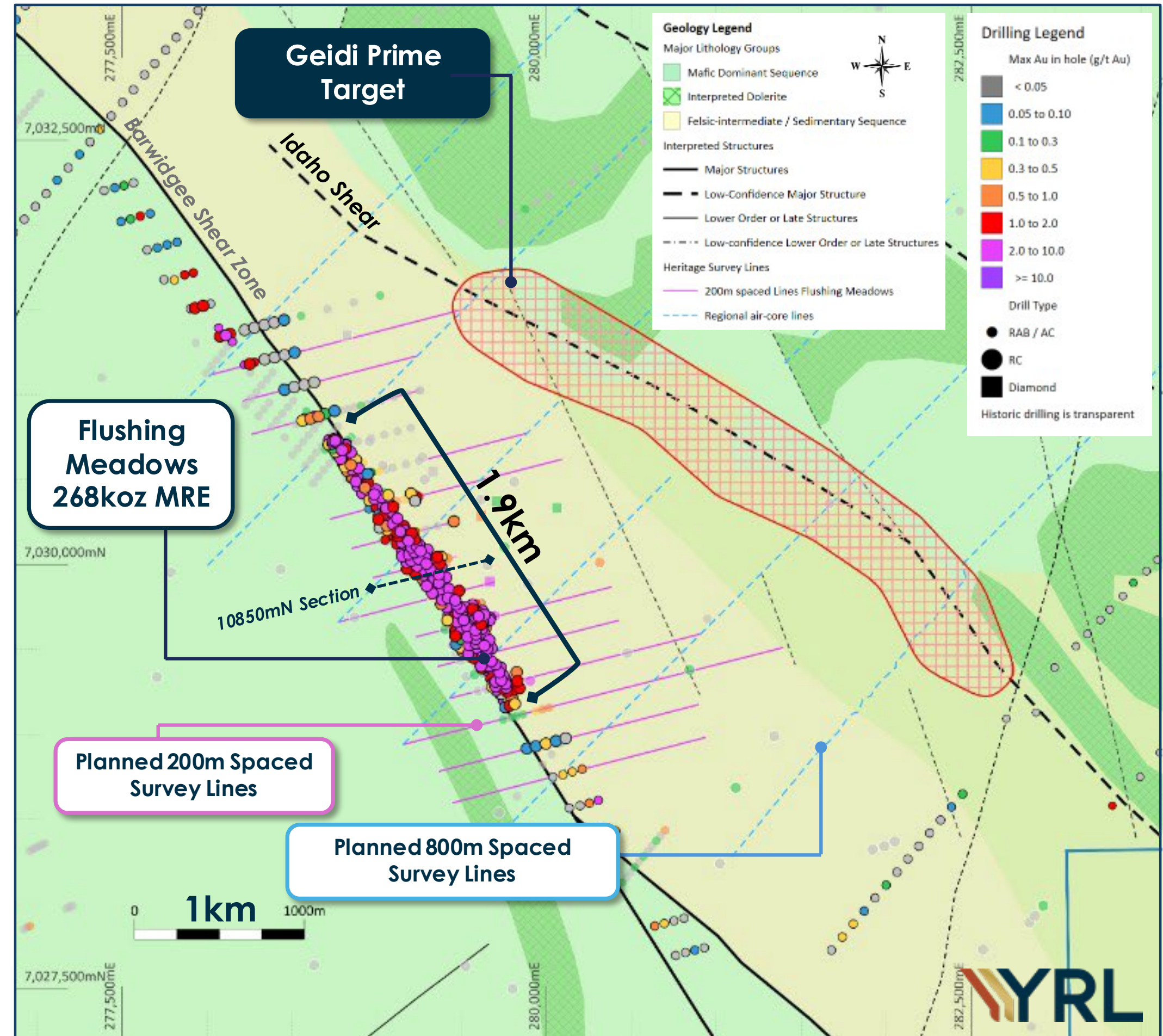
77% oxide and transitional mineralisation

## Mineralisation from the surface

- **Unmined gold Mineral Resource** on a granted mining lease
- Predominantly oxide Resource **strikes over 1.9km**
- **50km** to Wiluna & **60km** to Jundee
- Limited drilling at depth, **fresh rock not systematically tested**
- Geological controls are poorly defined

## Significant Scale

- Extensive underexplored mineralised system
- Clear exploration opportunity within fresh rock below the current Mineral Resource Estimate
- No effective testing to the east and southeast

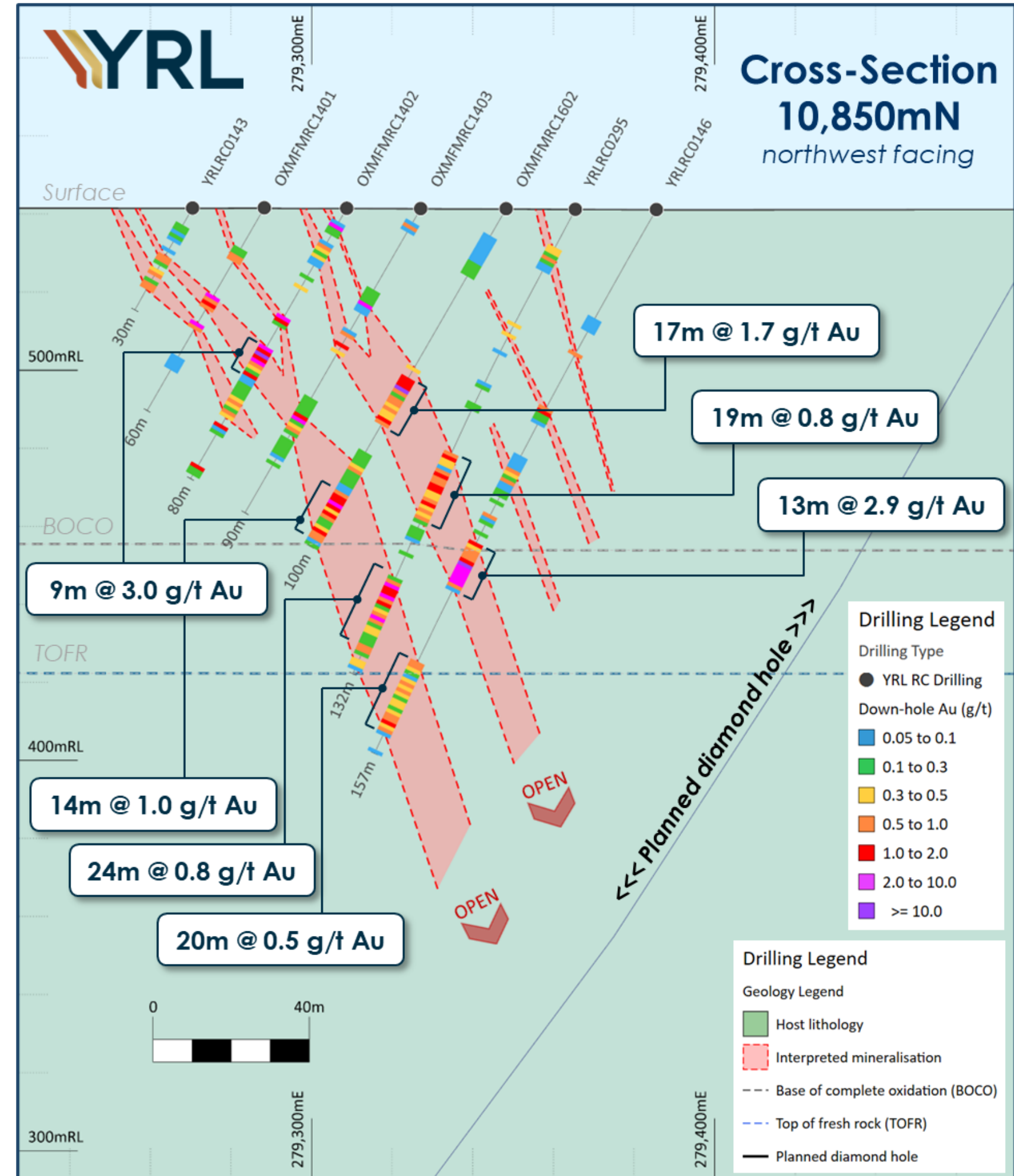
## Refocus Exploration

### Framework diamond program

- Diamond drilling is underway
- Program to follow that aims to:
  - > Assess fresh rock mineralisation potential over 1.6km of strike with eight 200m spaced holes
  - > Develop a geological model for the deposit

### Broader AC Program

- The area **between Geidi Prime and Flushing Meadows** is poorly tested
- Broad-scale air-core program is scheduled for mid-2026
- **Builds on geological learning** from the Siona and Arrakis gold discoveries in 2024 and 2025, respectively



# MT McCLURE - GROWTH AND DISCOVERY

## 182koz Gold Resource

### >12km Long Mineralised System on Granted Mining Leases

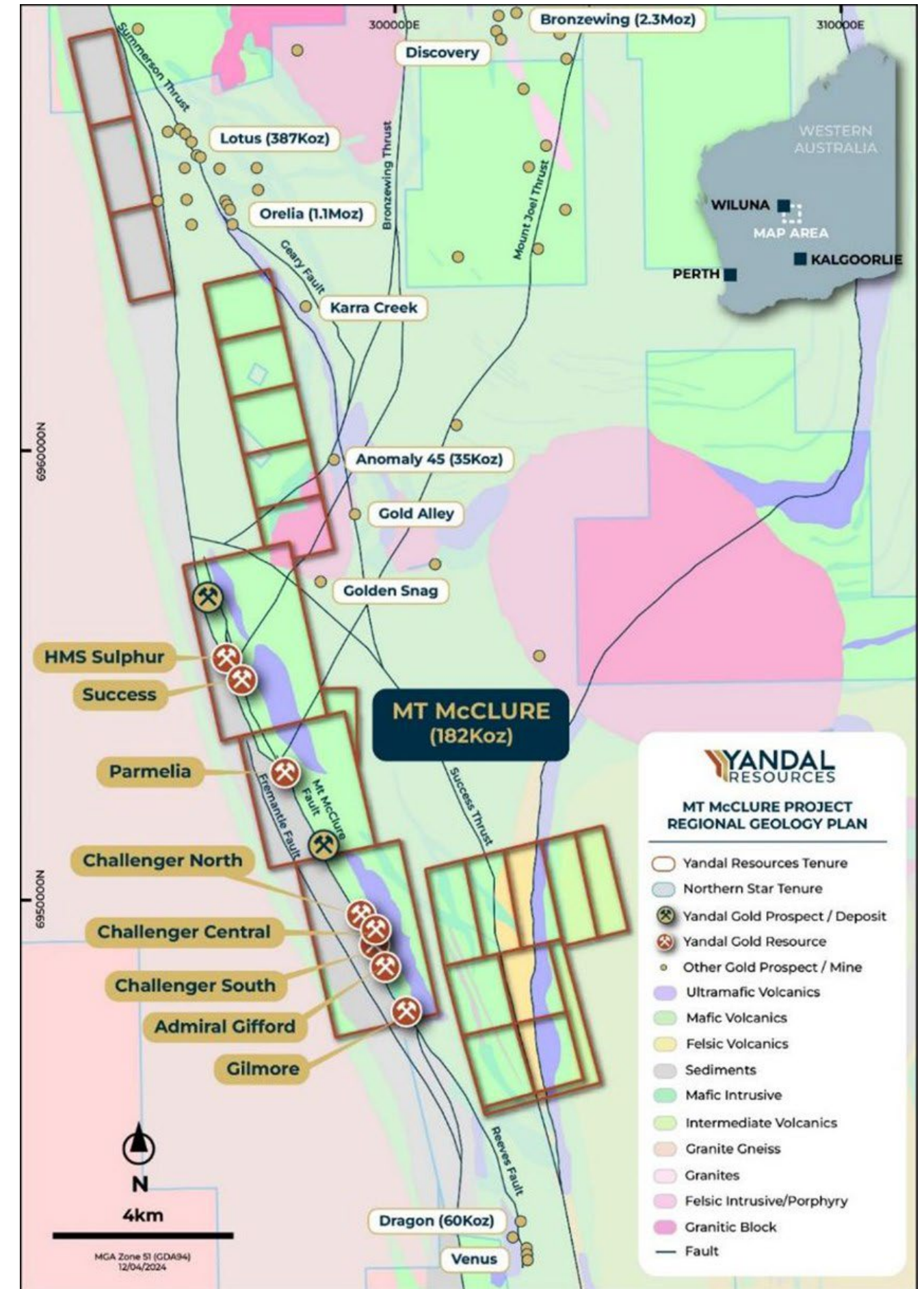
- Located adjacent to Northern Star's (ASX: NST) Orelia mining operation and 15km from the Bronzewing processing plant on care and maintenance

### Current Mineral Resources of 182,200oz Au @ 1.7g/t Au

- Remnant Resources below historic open pits
  - > Steep south plunging high-grade mineralisation is untested at depth
- HMS Sulphur provides proof of concept
  - > Shallow discovery potential with parallel structures
  - > Equivalent horizon untested across more than 10km of strike

### Ample Room for Further Resource Growth

- Higher grade south plunging shoots below historic open pits
- Parallel mineralisation is shallow and easily tested
