The Rule 10b5-1 trading plan is a pre-arranged written trading plan pursuant to which shares of the Issuer's common stock are sold automatically based on a predetermined formula that was established by the Reporting Person at a time when the Reporting Person was not aware of any material nonpublic information about the Company.
- The price reported in Column 4 is the weighted average price. These shares were sold in multiple transactions at prices ranging from \$43.59 to \$44.56, inclusive, per share. The Reporting Person undertakes to provide to the Issuer, any securityholder of the Issuer or the Staff of the Securities and Exchange Commission, upon request, full details regarding the number of shares sold at each separate price within the range.
- The price reported in Column 4 is the weighted average price. These shares were sold in multiple transactions at prices ranging from \$44.59 to \$44.70, inclusive, per share.
