Macquarie intends to buy-back up to \$2 billion of its ordinary fully paid shares under the on-market buyback (of which approximately \$1,013m has been completed as of 20 March 2026). Macquarie Capital (Australia) Limited has been engaged as structuring advisor on the buy-back.
