## TY-26/27 Guidance and Q1-26 Distribution

Dalrymple Bay Infrastructure Limited (ASX:DBI) (DBI or the Company) today announces its forecast Terminal Infrastructure Charge and distribution guidance for TY-26/27,<sup>1</sup> together with its Q1-26 distribution.

### Highlights

- Forecast Terminal Infrastructure Charge (TIC) applicable at Dalrymple Bay Terminal (DBT) for TY-26/27 of ~\$4.02 per tonne,<sup>2</sup> up ~8.1% on TY-25/26.
- Distribution guidance for TY-26/27 totalling 28.62 cents per stapled security (cps) to be paid in quarterly distributions, reflecting an 8.5% uplift on distribution guidance referable to TY-25/26 of 26.375 cps.<sup>3</sup>
- DBI announces its Q1-26 distribution of 6.750 cps, in line with prior guidance.

### Forecast Terminal Infrastructure Charge – TY-26/27

The forecast TIC applicable at DBT for TY-26/27 is ~\$4.02<sup>2</sup> per tonne. DBIM<sup>4</sup> levies the TIC on each tonne of contracted capacity at DBT, with the terminal fully contracted on a 100% take-or-pay basis at 84.2Mtpa to 30 June 2028 with evergreen renewal options for customers.

The forecast TY-26/27 TIC comprises:

- **Base TIC:** Indexed annually in line with the quarterly Australia all groups Consumer Price Index (CPI). The TY-26/27 Base TIC component has increased to \$3.66 per tonne, reflecting a 4.09% increase on TY-25/26;
- **NECAP Charge:** Non-expansory capital expenditure (NECAP) at DBT earns a return on invested capital set at the 10 Year Australian Government Bond<sup>5</sup> rate plus a margin, as well as a return of the invested capital in the form of a depreciation allowance. The expected increase in the NECAP Charge of approximately \$0.15 per tonne to approximately \$0.35 per tonne for TY-26/27 is based on an additional \$97.8m in commissioned NECAP expenditure for the previous 12-month period, which will be included in the NECAP asset base on 1 July 2026<sup>6</sup>; and
- **QCA Levy:** A pass through of the Queensland Competition Authority's (QCA) costs. The QCA Levy for TY-26/27 is expected to be approximately \$0.00 per tonne.

### TY-26/27 Distribution Guidance

DBI is also pleased to announce its distribution guidance for the year commencing 1 July 2026 (TY-26/27) totalling 28.62 cps to be paid in quarterly distributions, reflecting an 8.5% increase over TY-25/26 distribution guidance of 26.375 cps.<sup>9</sup>

DBI reaffirms its distribution per security growth target of 3-7% per annum for the foreseeable future, subject to business developments and market conditions. The TY-26/27 distribution guidance remains in line with our distribution policy established on listing of targeting to distribute between 60-80% of Funds from Operations (FFO).<sup>10</sup>

Distributions for TY-26/27 are expected to comprise both payments of dividends and partial repayments of the loan notes which form part of DBI's stapled securities.

### Q1-26 Distribution

DBI today announces its Q1-26 distribution of 6.750 cps. The Q1-26 distribution is in line with the Company's previous guidance of delivering total distributions for TY-25/26 of 26.375 cps.

The Q1-26 distribution will have a record date of 26 May 2026 and a payment date of 12 June 2026. The distribution will be paid to securityholders as an unfranked dividend of 4.8541 cps and a partial repayment of the loan notes which are part of DBI's stapled securities of 1.8959 cps.
