## HIGH-GRADE GOLD EXTENDS EAST OF 309 RESOURCE AT TWIN HILLS

**GBM Resources Limited (ASX: GBM)** ("GBM" or "the Company") is pleased to announce the first round of assay results from the Stage 2 drilling program at the 309 deposit, within the Company's Twin Hills Gold Project (~1.0Moz Au MRE) in the Drummond Basin, Queensland.

### Highlights:

- **High-grade gold intersected outside of the current 309 Mineral Resource Estimate ("MRE")**, supporting resource growth beyond the existing resource envelope.
- Significant assays results include<sup>1</sup>:
  - **21m @ 2.50g/t Au** from 158m (TNDH026) including:
    - **4m @ 9.24g/t Au** from 165m
  - **14m @ 2.99g/t Au** from 194m (TNDH026) including:
    - **5m @ 6.86g/t Au** from 195m.

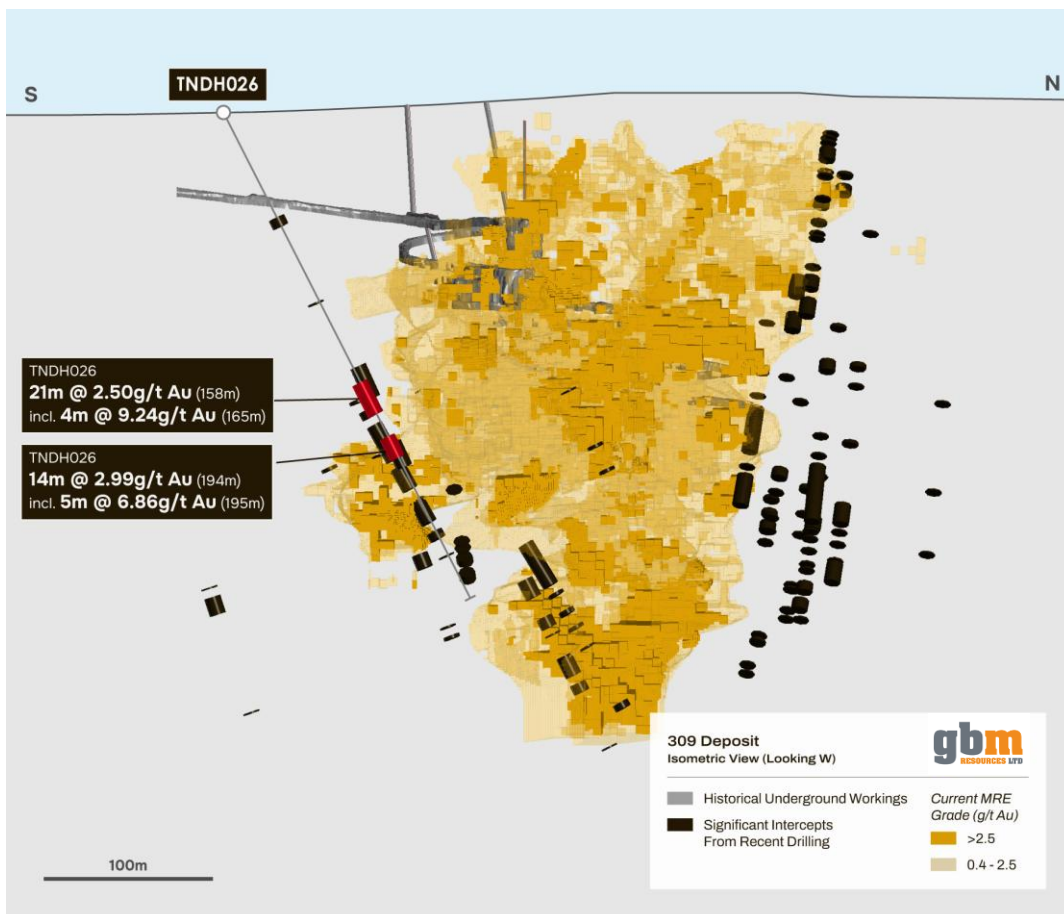


Figure 1: Areas of potential MRE growth from recent drilling at 309.

<sup>1</sup> Significant assay results have been calculated using an Au cutoff grade of 0.4g/t Au in line with the cutoff grade used for reporting Mineral Resources. Allowable internal dilution is 4m. Where a significant assay result is referred to as being included as part of a larger interval, an Au cutoff grade of 2.0g/t Au has been used, and allowable internal dilution is 2m.

- Additional drilling continues to demonstrate continuity of mineralisation and supports the Company's evolving geological and structural understanding of mineralisation at 309.
- **Three drill rigs operating across Lone Sister and 309 deposits at Twin Hills**, with further assay results expected progressively from the ongoing Stage 2 drilling program.
  - Assays results pending for 20 drill holes (15 at Lone Sister and 5 at 309). Significantly more holes completed at Lone Sister due to a higher proportion of reverse circulation ("RC") drilling.
- **Preparation to drill the Yandan deposit (0.44Moz @ 1.1g/t Au incl. 0.20Moz @ 5.7g/t Au) is underway.** The deposit is fully open at depth and along strike and supplemented with recent geophysical surveys.

**GBM Chief Executive Officer, Daniel Hastings, commented:**

*"Definition of the larger mineralised system at 309 is progressing well, with drilling continuing to support resource growth potential beyond the current MRE, while also improving the Company's understanding of the broader mineralised system and potential higher-grade zones at depth.*

*We are encouraged by the continued discovery of new zones well outside the existing MRE, particularly within the upper portion of the orebody. The Company aims to expand these new zones to grow the open pit MRE at 309.*

*In addition to the near-surface resource growth opportunity, the Company is refining its multielement geochemical and structural models to assist targeting of higher-grade mineralisation at depth. The system is growing, with the assay results and the geology increasingly supporting that interpretation."*

### 309 DRILLING

Following encouraging Stage 1 results at the 309 deposit, including **37m @ 5.00g/t Au from 225m** (TNDH012), the Company commenced a 50,000m Stage 2 drilling program at Twin Hills aimed at supporting further resource growth and advancing the project towards future development studies.

The current drilling program is targeting extensions to known mineralisation, near-surface resource growth opportunities adjacent to the current MRE and potential higher-grade mineralisation at depth, while also providing important geological, metallurgical and geotechnical data to support future project studies.

Initial results from the Stage 2 drilling program continue to support extensions to mineralisation outside the current 309 MRE, with recent drilling intersecting gold mineralisation along strike and at depth from the existing resource envelope. Results from TNDH026 are particularly encouraging, with high-grade mineralisation intersected east of the current MRE, demonstrating the potential for mineralisation to extend beyond the current eastern limits of the 309 resource model.

Drillhole TNDH026 was drilled east of the current MRE, targeting extensions to mineralisation identified from previous drilling and intersected:

- **21m @ 2.50g/t Au** from 158m, including **4m @ 9.24g/t Au** from 165m; and
- **14m @ 2.99g/t Au** from 194m, including **5m @ 6.86g/t Au** from 195m.

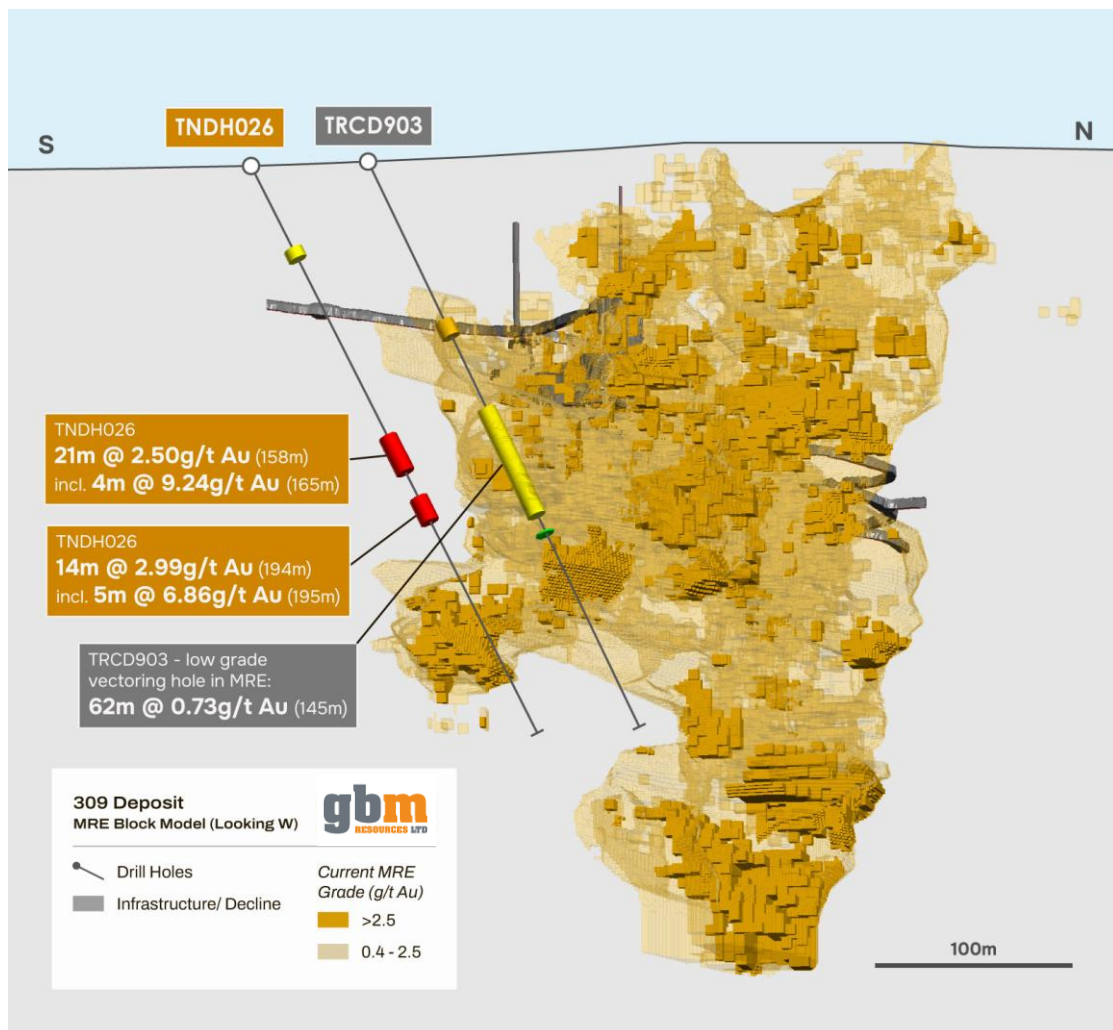


Figure 2: TNDH026 drilled outside of the MRE block model, demonstrating potential MRE growth.

Additional drilling continues to support continuity of mineralisation outside the current MRE along strike and at depth. Significant results include:

- **8m @ 1.39g/t Au** from 269m (TNDH016)
- **13m @ 1.00g/t Au** from 249m (TNDH020)
- **13m @ 0.57g/t Au** from 103m (TNDH021) and **11m @ 0.56g/t Au** from 128m

Several holes also intersected broader zones of lower-grade mineralisation and alteration, which are continuing to refine the Company's geological and structural understanding of the broader system.

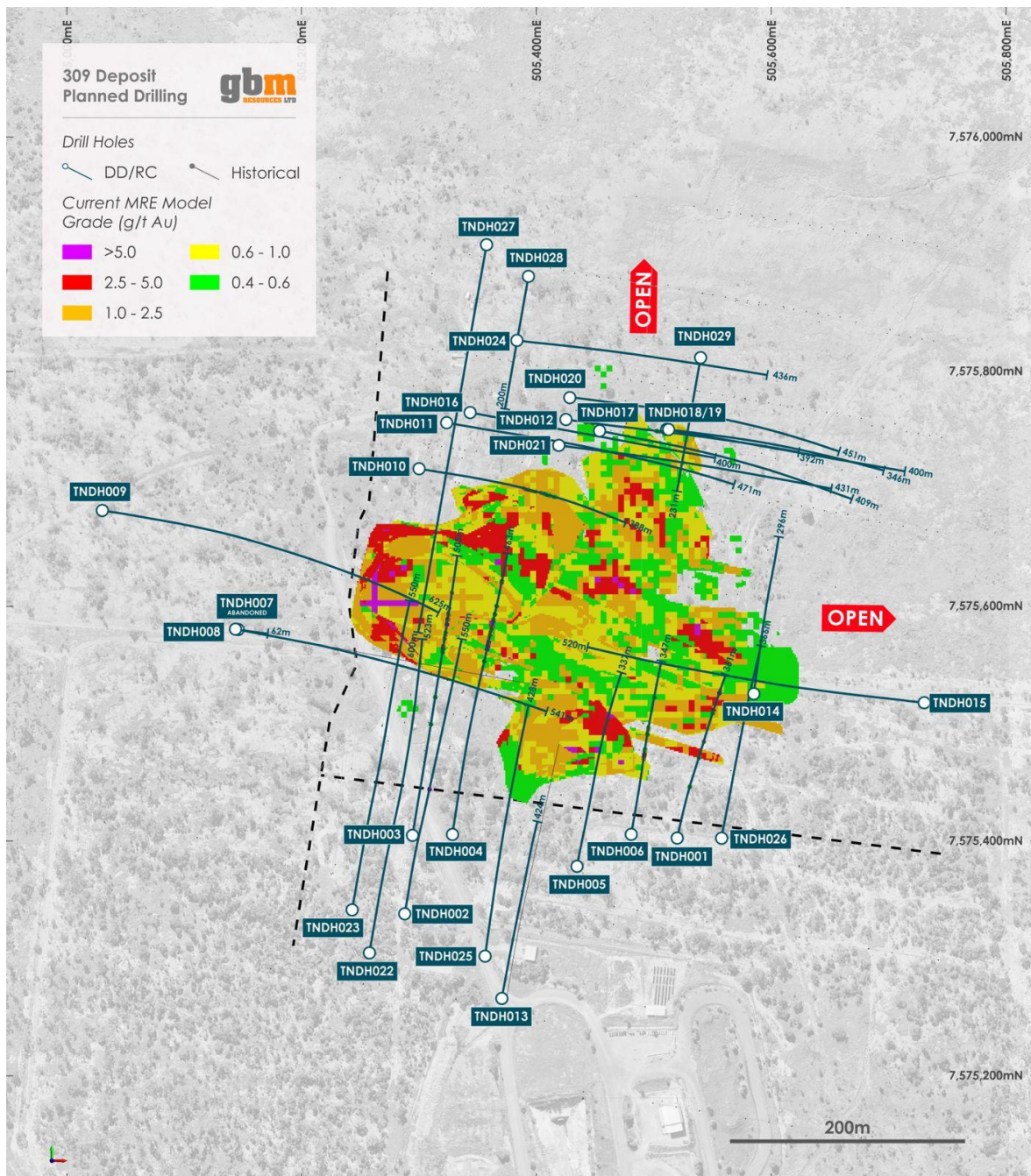


Figure 3: Plan view of Stage 2 drill holes at the 309 deposit.

Results from ongoing drilling continues to improve the Company's understanding of the 309 mineralised system, with new geological and geochemical insights assisting the targeting of higher-grade mineralisation. The clear, interpreted zonation of gold and its correlation with pathfinder elements, combined with a new geological and structural model, will assist in targeting for future drilling.

This evolving approach has already delivered encouraging results, including TNDH026, which intersected high-grade mineralisation outside the current MRE and approximately 60m from the nearest drillhole.

TNDH016 and TNDH017 were drilled to follow up the high-grade mineralisation intersected in TNDH012, which returned 37m @ 5.0g/t Au from 225m including 3m @ 29.96g/t Au. Both holes intersected additional zones of mineralisation surrounding TNDH012, supporting the interpretation that gold mineralisation extends beyond the original high-grade intercept and may continue along strike within the northern portion of the deposit. Results from TNDH016 included 8m @ 1.39g/t Au from 269m, while TNDH017 (off the northern end of the current MRE) intersected several shallower mineralised intervals. **These results support the potential for resource extensions to both the east and west of TNDH012.**

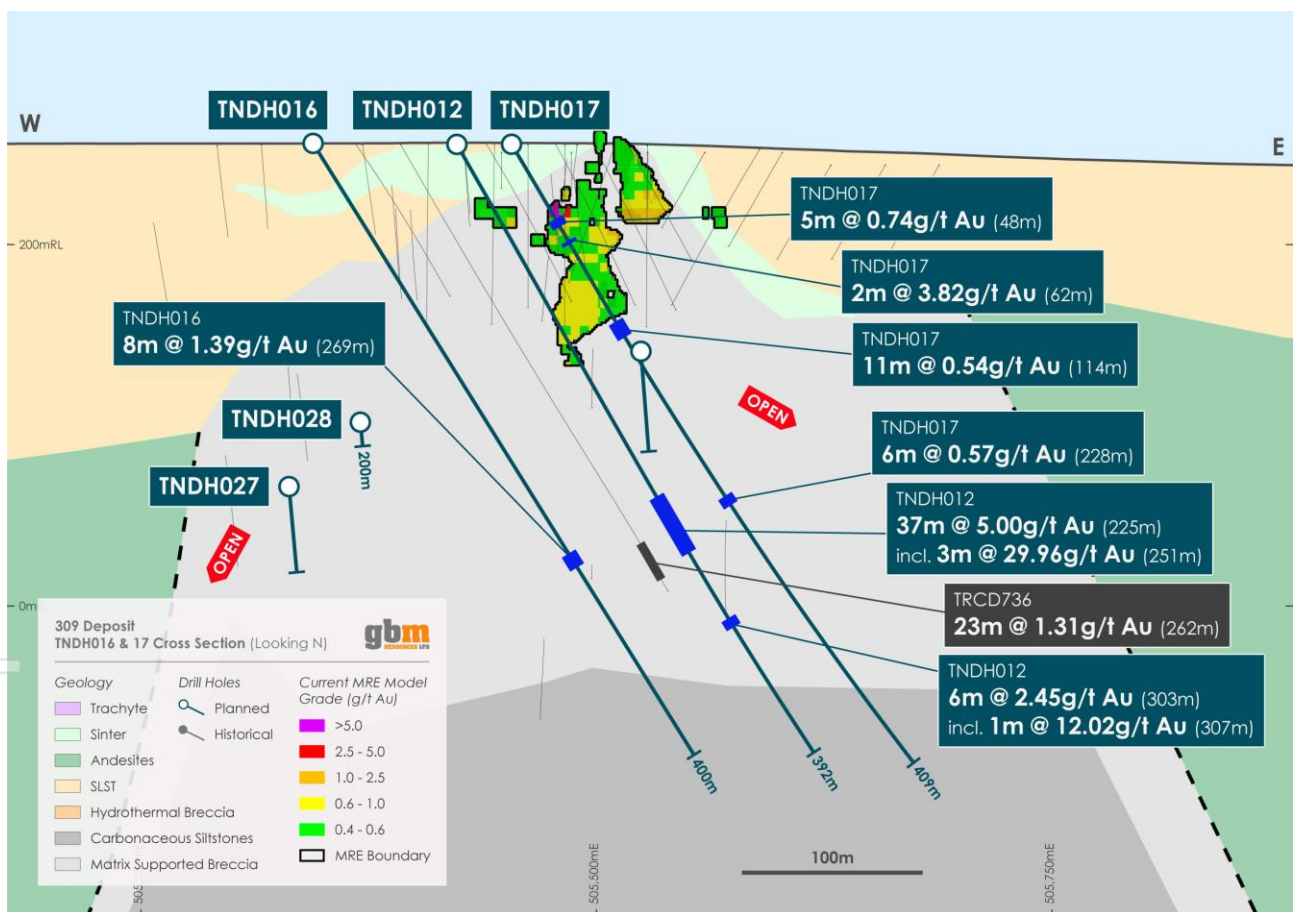


Figure 4: Drill holes TNDH016, TNDH017 and TNDH012 in cross section.

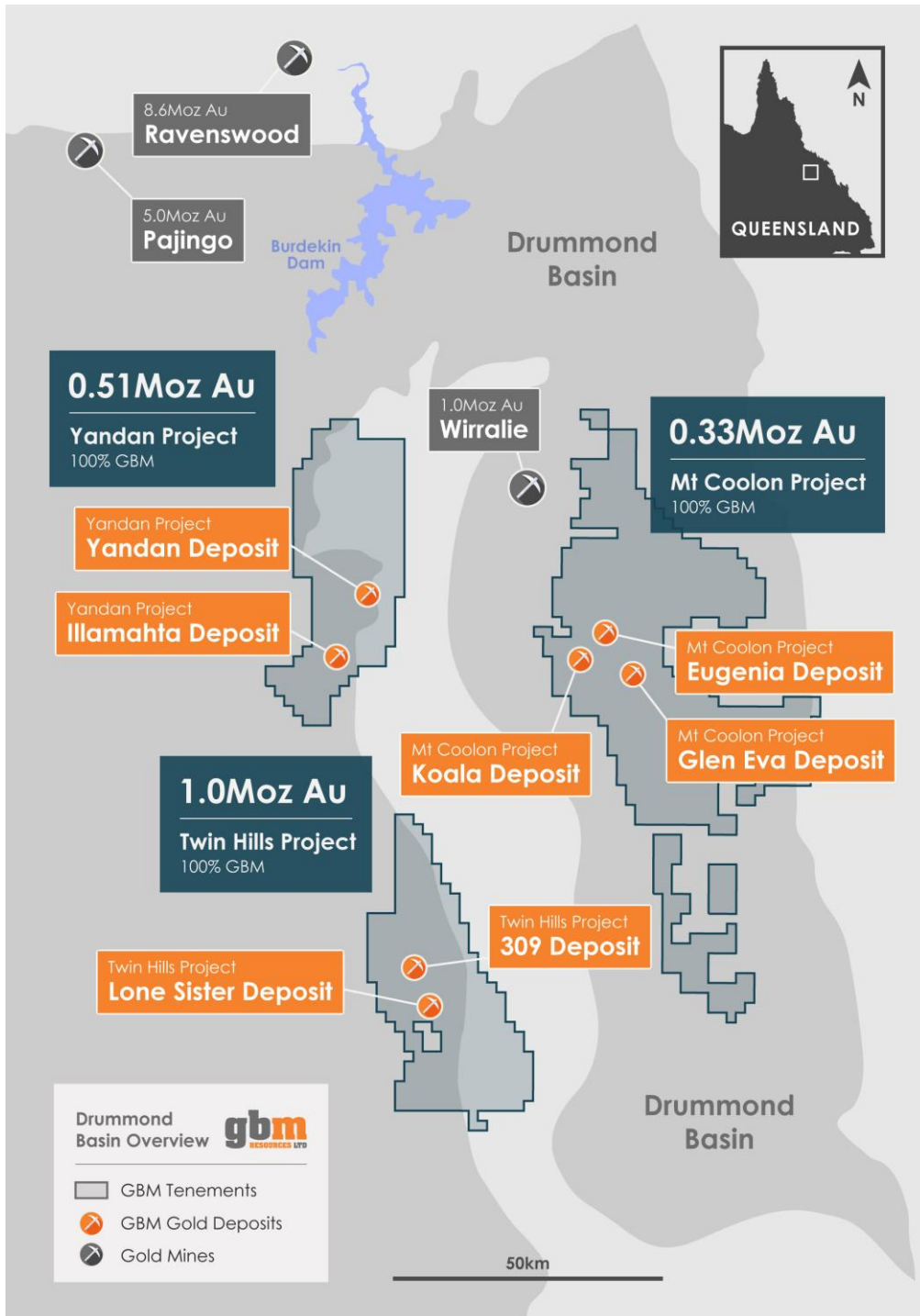


Figure 5: Drummond Basin Portfolio.
