The profit for the Group after providing for income tax amounted to \$14,302,000 (31 March 2025: \$24,757,000). The decrease reflects the fact that the prior year included the partial recognition of deferred tax assets, which generated an income tax benefit of \$18.4 million in 2025 and \$3.0 million in 2026. Excluding the impact of this tax expense benefit, profit after income tax increased 78%.

The increase in the net tangible assets per security has been largely driven by the increase in net assets of the Group. The increase in net assets has been largely driven by the contribution of statutory profits of \$14.3 million and the increase in derivative assets of \$30 million.
