



## COURT DETERMINES MAYNE PHARMA ENTITLED TO \$13.27M PAYMENT FOR LEGAL COSTS FROM COSETTE

**22 May 2026, Adelaide, Australia:** Mayne Pharma Group Limited (Mayne Pharma or the Company) (ASX: MYX), is pleased to announce that Mayne Pharma has today been awarded \$13,269,328.04 in legal costs following its success in the proceedings last year against Cosette Pharmaceuticals, Inc (Cosette).

In June 2025, Mayne Pharma commenced proceedings against Cosette in the Supreme Court of New Wales (**Court**) in relation to Cosette's purported termination of the Scheme Implementation Deed signed by Mayne Pharma and Cosette in February 2025 (**Termination Proceedings**).

In October 2025, the Court delivered judgment in favour of Mayne Pharma dismissing all of Cosette's claims. The Court also made an adverse costs order against Cosette, requiring Cosette to pay Mayne Pharma's costs of the proceedings as agreed or assessed.

Today, the Court delivered judgment requiring Cosette to pay Mayne Pharma's legal costs of the Termination Proceedings in the amount of \$13,269,328.04, plus interest.

The Court is expected to make orders to give effect to the judgement shortly, including in relation to the amount of interest to be paid by Cosette, the timeframe for payment and with respect to Mayne Pharma's costs associated with its application for costs.
