Key Contract Awards and Infrastructure Upgrades

Dianne Copper Mine Project workstreams advancing strongly

Key Dianne milestones

- Appointment of local contractor, CEMACC, to undertake all development civil earthworks.
- CEMACC to then seamlessly transition to operations (mining, crushing, leach pad loading).
- Site access road upgrades complete, fully traversable via heavy haul truck.
- Accommodation village refurbishment, upgrade and expansion also complete.
- Advancing Dianne funding options, with negotiations well progressed.
- Final Investment Decision (FID) targeted in coming months, subject to funding.
- Civil earthworks program set to commence upon FID being taken.
- First copper cathode output expected within 12 months of FID.

Revolver Resources Holdings Limited (ASX:RRR) (Revolver or the Company) provides an update on further key milestones achieved ahead of targeted FID and full-scale development commencement on its Dianne Copper Mine Project in north-west Queensland.

Revolver Managing Director, Pat Williams, commented:

“The Revolver team is driving hard towards targeted FID on the Dianne Copper Mine Project. Financing discussions have progressed, and are now in the advanced due diligence and documentation negotiation phase. In parallel with our financing workstream, key contract awards and site works continue to prepare critical Dianne infrastructure for the commencement of full-scale construction activities.”

Earthworks and mining contract awarded

Revolver has contracted local Cape York services business, CEMACC Pty Ltd, to undertake all civil earthworks activities required for development of its Dianne Copper Mine Project (including site roads, drains, dams, leach pads and material importation area).

Following completion of these development activities, CEMACC will then transition into the provision of mining, crushing and leach pad loading services for Dianne operations.

Major equipment to be supplied by CEMACC and delivered to site in coming weeks includes: 70t hydraulic excavator, 50t hydraulic excavator, D9 dozer, 140 grader, 4 x 45t articulated dump trucks, and water and support trucks.



The civil earthworks program is scheduled to commence promptly upon Revolver taking a positive FID on the Dianne Copper Mine Project.

Accommodation village and site access road upgrades complete

Following the recent wet season, upgrade works on the 10km Dianne site access road have now been completed. This road is key to enabling the inflow of supplies and equipment required for the construction and operation of the Dianne Copper Mine Project.

The completion of these upgrade works means that the road is now traversable by heavy haul trucks, supporting the next phase of development activities at Dianne.

Refurbishment, upgrade and expansion of the existing Dianne accommodation village is also now complete. These works deliver capacity to support an initial 25 personnel for the targeted commencement of full-scale construction activities at Dianne.

About the Dianne Copper Mine Project

The broader Dianne Project is located in northern Queensland, approximately 260km north-west of Cairns within the polymetallic Hodgkinson Province.

The Dianne Deposit, which previously hosted one of the highest-grade operating copper mines in the world, is situated in the eastern part of the Dianne Project. Revolver's Dianne Copper Mine Project is focused on a low capital cost, heap leach / SX-EW development of the existing Mineral Resource at the Dianne Deposit.

Revolver's regional exploration strategy at the Dianne Project also continues to test the volcanogenic massive sulphide (VMS) and intrusive related gold system (IRGS) potential in the Larramore Volcanics Belt, located to the west of the Dianne Deposit.

The Dianne Copper Mine Project is proudly supported by the Queensland Critical Minerals and Battery Technology Fund.
