## Muzinich BDC Income Fund – Active ETF

### BDCI Targets 10.65% Indicative Annualised Yield with Monthly Distributions of \$0.17

AGP Investment Management Limited (**AGP IM**), as responsible entity for the Muzinich BDC Income Fund – Active ETF (**BDCI** or the **Fund**) is pleased to announce that the Fund will pay a distribution of \$0.17 per unit for the month ending 31 May 2026. It is estimated that this distribution will be unfranked.

AGP IM confirms the Fund’s intention to pay monthly distributions of \$0.17 per unit for each of the 14 months ending 30 June 2027<sup>1</sup>. This represents an indicative 12-month yield of approximately **10.65%**<sup>2</sup> and an indicative 14-month yield of approximately **12.43%**<sup>2</sup>.

**Distribution Reinvestment Plan Opportunity**

The DRP provides unitholders with a cost-effective means of maximising their investment in the Fund by reinvesting their distributions into additional units in the Fund. Units issued under the DRP will be free of any brokerage, commission, stamp duty and other transaction costs and will rank equally with existing units from the date of issue.

The issue price for units allotted under the DRP will be the Fund's net asset value per unit, ex-distribution, determined as at last day of the relevant distribution period. Any residual amounts will count towards future DRP allotments.

To take part in the DRP, we recommend speaking with your financial adviser or completing the steps outlined below.

2. Selecting issuer name "AGPL - AGP INVESTMENT MANAGEMENT LIMITED" and selecting BDCI as the Fund;
3. Selecting 'Payments & Tax' then 'Reinvestment Plans';
4. Selecting 'Create Instructions' under BDCI in the 'Action' section; and
5. Selecting either 'Full Participation' or 'Partial Participation'.
