**Change in Relevant Interest – Transfer to LATAM Leadership Team**

Frontier Digital Ventures Limited (ASX: FDV) (“FDV” or the “Company”) provides the attached Appendix 3Y’s – Change of Director’s Interest Notices for Executive Directors Patrick Grove and Lucas Elliott in relation to a transfer of a portion of their FDV shareholding held by Catcha Group Pte Ltd.

The transfer was made to senior leadership members of FDV’s Latin American operations, who acquired the shares alongside Mr Grove and Mr Elliott at the same price in the recent acquisition of a strategic block of FDV shares previously disclosed to the market.

The transaction reflects the continued alignment of FDV’s operating leadership with shareholders and increases direct equity ownership among key executives responsible for the Group’s core Latin American business.

Importantly, the transfer does not reflect any change in Mr Grove or Mr Elliott’s commitment to FDV or its long-term strategy and they remain the Company’s largest shareholder.

The Board believes increasing ownership participation among senior operating executives strengthens long-term alignment, accountability and shareholder value creation.
