## ASX Announcement

### Autosports Group amends Syndicated Facility Agreement to facilitate growth

Autosports Group Limited (ASX: ASG) announces that it has agreed an amendment to its existing AUD \$350 million Syndicated Facility Agreement with Commonwealth Bank of Australia, Westpac Banking Corporation, BMW Australia Finance Limited and Mercedes-Benz Financial Services Australia Pty Ltd, subject to the satisfaction of customary conditions precedent.

The amendment includes increasing the total aggregate facility limit by AUD\$85 million to AUD\$435 million, extending the maturity of Facility 1 and Facility 2 from 3 years to 4 years, and improving certain financial covenant terms, to further support future growth initiatives. The increased limit is allocated as follows:

- Facility 1 and Facility 2 – increase from AUD\$250 million to AUD\$335 million in aggregate.
- Facility 3 – unchanged at AUD\$100 million in aggregate.

Financial close to is expected to occur around mid-June 2026.
