Arafura Rare Earths Limited (ASX: ARU) (Arafura or the Company) is pleased to confirm that its share purchase plan (SPP) announced on 22 May 2026 opens today following lodgement of the SPP prospectus with ASIC.

The Company has also today despatched its notice of meeting for an extraordinary general meeting to be held on Thursday 2 July 2026. The meeting will be held at the offices of BDO at Level 9, Mia Yellagonga Tower 2, 5 Spring Street, Perth WA 6000 at 11:45am (AWST). A copy of the notice of meeting will be released to ASX following this announcement.

RE: SHARE PURCHASE PLAN

On 22 May 2026, **Arafura Rare Earths Limited (ASX: ARU) (Arafura, or the Company)** announced a Share Purchase Plan (**SPP**) to raise A\$25 million (before costs).

The SPP will provide Eligible Shareholders (defined below) an opportunity to subscribe for up to A\$30,000 worth of new fully paid ordinary shares (**New Shares**) without incurring any brokerage or other transaction costs.

The SPP is open to all eligible existing shareholders on the Company's share register at 7.00pm (AEST) on Thursday, 21 May 2026 (**Record Date**) with a registered address in Australia or New Zealand (**Eligible Shareholders**), unless:

- a) you are in the United States or acting for the account or benefit of a person in the United States; or
- b) you hold Arafura shares on behalf of another person who resides outside Australia or New Zealand,

in which case you will not be eligible to participate in respect of the shares of that person.

The offer price under the SPP is A\$0.26 per New Share, which represents a 16.1% discount to the last closing price of shares on 21 May 2026 (being the date prior to the announcement of the SPP) of A\$0.310.

Eligible Shareholders may apply for a parcel of New Shares valued at A\$2,500, A\$5,000, A\$10,000, A\$20,000, A\$25,000, A\$30,000. Participation in the SPP is optional.

The SPP is subject to the terms and conditions set out in the prospectus in relation to the SPP that was lodged with ASIC (and released to ASX) on 3 June 2026 (**SPP Prospectus**). The issue of New Shares under the SPP (and under any SPP shortfall offer) is subject to shareholder approval, which will be sought at a general meeting of the Company to be held on or around 2 July 2026.
