### ReNerve appoints UG Medical as distribution partner for Malaysian market

#### Key Highlights

- Distribution agreement executed with UG Medical, an established medical device distributor with an extensive network across Malaysia
- Agreement covers the Malaysian market, with a population of approximately 33 million people, and a rapidly growing healthcare sector
- NervAlign received regulatory clearance in Malaysia earlier this year via the Medical Device Authority (MDA)

**ReNerve Limited** (ASX, "ReNerve" or "the Company"), an Australian biotechnology company developing innovative products for peripheral nerve injury ("PNI") repair, announced today that it has partnered with UG Medical as its commercialisation partner for the NervAlign products in the Malaysian market.

Under the terms of the agreement, UG Medical Services Sdn Bhd (UG Medical) will be responsible for the importation, regulatory management and warehousing and will work with the ReNerve team across marketing, sales and distribution of the NervAlign product range within Malaysia. ReNerve has its NervAlign Nerve Cuff approved in Malaysia and is looking to launch its nerve conduit product later this year. ReNerve will provide ongoing clinical and technical support, product training and regulatory liaison to support UG Medical's commercialisation activities. The agreement has an open-ended term and is on customary commercial terms for medical device distribution arrangements.

Commercialisation in Malaysia with UG Medical will be supported by ReNerve's Asia sales and marketing team, who has already built relationships with hospitals in the region. Additionally, ReNerve will be a major sponsor for the hand surgery teaching event in Kuala Lumpur in June 2026<sup>1</sup>.

"This agreement with UG Medical represents a compelling opportunity to establish NervAlign in the Malaysian market, which is one of Southeast Asia's most progressive and well-developed healthcare systems. UG Medical's relationships and in-market expertise make them an outstanding partner for ReNerve as we continue to build our commercial presence across the Asia-Pacific region," said Dr Julian Chick, CEO of ReNerve.

"NervAlign addresses a significant and underserved clinical need in peripheral nerve repair and Malaysia's growing investment in surgical infrastructure and specialist care creates a strong environment for adoption. We look forward to working with the UG Medical team to bring NervAlign to surgeons and patients across Malaysia."

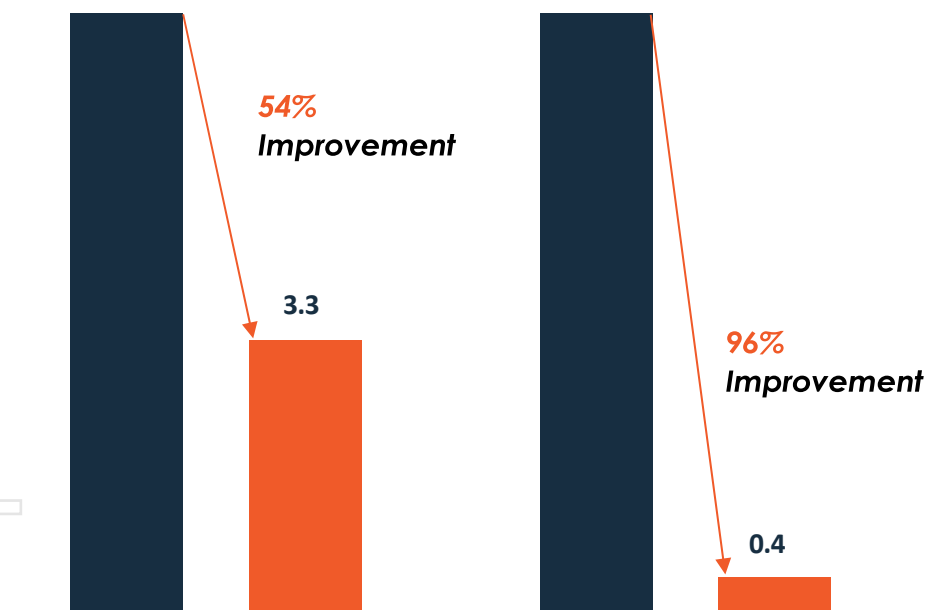

ReNerve's first flagship product, the FDA-cleared **NervAlign® Nerve Cuff**, is already making a dramatic difference in surgical outcomes across the United States. A recently announced clinical study has demonstrated remarkable results, showing that patients treated with the NervAlign® Nerve Cuff experienced post-surgical pain scores dropping from 7.1 to just 0.4, compared to from 7.1 to 3.3 without the device being used – a statistically significant improvement that's changing lives.

- **Empliq™ Amniotic tissue product ranges** -- Three amniotic tissue product ranges used to aid the healing of wounds.

### *In development*

- **NervAlign® Nerve Conduit Range** – Next-generation nerve conduit leveraging advantages of eCOO technology in a material designed to facilitate nerve growth over short gaps between nerve ends.
- **NervAlign® Nerve Guide Matrix** – a customised and ready-to-use alternative to existing nerve grafts, for treatment of longer nerve gaps and more severe nerve injuries. It will eliminate the need for patients to undergo additional sural nerve harvesting.
- **NervAlign® Bionic Nerve** – Next-generation combination technology for the most challenging nerve repairs.

## Market Leadership and Growth

With demonstrated market traction since the Company's 2022 product launch, ReNerve achieved 53% revenue growth in FY25, reaching \$271k in sales and YTD FY2026 sales revenues showing further significant increases across its portfolio. Our high-margin, scalable products are positioning us as the go-to solution for surgeons seeking superior patient outcomes in the rapidly expanding global nerve repair market, valued at US\$1.6 billion in 2024 and is projected to reach \$6.2 billion by 2031.<sup>4</sup>
