47th and 48th Copper Concentrate Shipments Dispatched from Sohar Port

Perth, Australia: Alara Resources Limited (ASX: AUQ) (**Alara** or the **Company**), a base and precious metals producer and explorer with projects in Oman, is pleased to announce the dispatch of its 47th and 48th shipments of copper concentrate from its Al Wash-hi Majaza copper-gold mine in Oman. The Al Wash-hi Majaza mine is operated by Alara's joint venture company Al Hadeetha Resources LLC (**AHRL**). Alara holds a 51% interest in AHRL.

Key Highlights

- **Total 2135 WMT copper-concentrate shipped, comprising 412 MT copper and 301 Oz gold**
- **47th shipment of 1066 WMT copper-concentrate shipped on 9th June, comprising 204 MT copper and 166 Oz contained gold**
- **48th shipment of 1069 WMT copper-concentrate shipped on 11th June, comprising 208 MT copper and 135 Oz contained gold**

The Al Wash-hi Majaza copper-concentrate plant has shipped a total quantity of 2135 WMT of copper-gold concentrate with approximately 412 MT of contained copper and approximately 301 Oz of gold in its latest shipping cycle. This comprises the 47th and 48th parcels of copper-concentrate exported from the plant, departing Sohar Port June 9 and 11, respectively.
