Second Supplementary Target's Statement

1 Important information

This document is a supplementary target's statement under section 644(1) of the *Corporations Act 2001* (Cth). It is the second supplementary target's statement (the **Second Supplementary Target's Statement**) issued by Cue Energy Resources Limited (ACN 066 383 971) (**Cue**) in relation to the off-market takeover bid made by Horizon Oil Limited (ACN 009 799 455) (**Horizon**) for all the ordinary shares in Cue which Horizon (and its associates) do not already own or control (the **Offer**).

This Second Supplementary Target's Statement is dated 11 June 2026 and supplements, and should be read together with, Cue's target's statement dated 7 April 2026 (the **Original Target's Statement**) and the First Supplementary Target's Statement dated 14 April 2026 (the **First Supplementary Target's Statement**).

Capitalised terms in this Second Supplementary Target's Statement have the same meaning given in the Original Target's Statement, unless the context otherwise requires. The 'Important notices' section of the Original Target's Statement applies to this Second Supplementary Target's Statement. This Second Supplementary Target's Statement prevails to the extent of any inconsistency with the Original Target's Statement.

A copy of this Second Supplementary Target's Statement was lodged with ASIC and ASX on 11 June 2026. Neither ASIC, ASX nor any of their respective officers takes any responsibility for its contents.

2 Update on Horizon Takeover Offer

This Second Supplementary Target's Statement provides the formal response of the Independent Directors to Horizon's Third Supplementary Bidder's Statement dated 9 June 2026 under which Horizon declared the Offer Consideration to be "best and final". The Independent Directors noted, among other things, that:

- the Offer Consideration was declared "best and final" with no increase in the Offer Consideration, meaning that the Offer Consideration will not be increased in the absence of a competing proposal;
- other than the Cue Shares held by Echelon, Horizon has only secured acceptances in respect of approximately 2.4% of the total Cue Shares currently on issue;¹
- while several significant conditions to the Offer have been fulfilled, Horizon has not yet declared the Offer unconditional; and
- Cue remains well-capitalised to continue as a stand-alone company with an unaudited cash balance of A\$16 million as at 30 May 2026 and no debt.

As further detailed in section 3 below, the Independent Directors continue to unanimously recommend that Cue Shareholders **REJECT** the Offer by **TAKING NO ACTION**.

¹ Subsequent to Cue's announcement to the ASX on 10 June 2026, Horizon released a notice indicating that it had received acceptances in relation to a further 0.24% of the total Cue Shares currently on issue.

3 The Independent Board Committee continues to recommend that you **REJECT** the Offer

The Independent Directors have carefully considered the update contained in this Second Supplementary Target's Statement and continue to unanimously recommend that Cue Shareholders **REJECT** the Offer by **TAKING NO ACTION**.

The Independent Directors also continue to unanimously recommend that Cue Shareholders **REJECT** the Offer by **TAKING NO ACTION** for the other reasons set out in the Original Target's Statement and the First Supplementary Target's Statement.

Section 1 of the Original Target's Statement contains further details regarding the Independent Board Committee's recommendation.

4 Consents

Cue confirms that as at the date of this Second Supplementary Target's Statement, each of the parties that have been named as having consented to being named in the Original Target's Statement have not withdrawn that consent.

Update on Horizon Takeover Offer

Cue Energy Resources Limited (ASX:CUE) (**Cue**) refers to the unsolicited, off-market takeover offer (the **Offer**) by Horizon Oil Limited (**Horizon**) for Cue.

Notwithstanding the developments noted in Horizon's Third Supplementary Bidder's Statement released to the ASX on 9 June 2026 (**Third Supplementary Bidder's Statement**), the Cue Independent Board Committee (**IBC**) continues to unanimously recommend that Cue shareholders **REJECT** the Offer by **TAKING NO ACTION** in relation to all documents sent to you by Horizon.

The IBC's reasons for this recommendation remain as set out in Cue's Target's Statement (released to the ASX on 7 April 2026) (**Target's Statement**).

In addition, the IBC notes that:

- Horizon has declared the Offer consideration "best and final", with no increase in the Offer consideration proposed (in the absence of a competing proposal).
- As at the date of the Third Supplementary Bidder's Statement, other than Cue Shares held by Echelon Offshore Limited, Horizon has only secured acceptances in respect of 17,127,512 Cue Shares, or approximately 2.4% of the total Cue Shares currently on issue.¹
- If Horizon fails to obtain acceptances in respect of at least 80% of Cue Shares, scrip-for-scrip capital gains tax rollover relief will not be available to Cue Shareholders who accept the Offer.
- Whilst several significant conditions to the Offer have been fulfilled, Horizon has not yet declared the Offer unconditional. The date by which Horizon must provide notice of the status of the conditions of the Offer is 12 June 2026.
- Cue remains well-capitalised to continue as a stand-alone company. As of 31 May 2026, Cue held an unaudited cash balance of \$16 million with no debt.

The Offer is currently scheduled to close at 7:00pm (Sydney time) on 19 June 2026, unless it is further extended or withdrawn.
